1、 GMG International Tendering Co., Ltd., entrusted by Guangdong Yudean Yangjiang Offshore Wind Power Generation Company (hereinafter referred to as "the Bid Inviter" or "the Buyer"), now holds a public bid invitation for the Erection Works (Section B) of Offshore Structure of Yudean Yangjiang Shapa Offshore Wind Power Project. The Project accepts the bids of eligible enterprises from the member countries of "BRICS", who participate in the bidding as required by this announcement.

2、 Project Overview and Bidding Scope:

2.1 Project Overview:

The site of Yudean Yangjiang Shapa Offshore Wind Power Project is located in the sea area near Shapa Town, Yangxi County, Yangjiang City, Guangdong Province. The wind farm of this phase is located at a site with coordinates of 111.665°E, 111.552°E, 21.339°N and 21.377°N, and covers a sea area of 48 km². The site has a water depth of 23 m ~ 27 m, and its center is about 20km away from the shore.

The project is planned to have an installed capacity of 300MW and arrange 55 sets of WTGs with a capacity of 5.5MW, a 220kV offshore step-up substation and onshore control center. The WTGs generate electricity to the offshore step-up substation via a 35kV collector submarine cable. After increasing the voltage, electric energy is connected to the onshore control center via 2 220kV submarine cables and sent to the 220kV energy collector via overhead lines.

3、 Qualification of Eligible Bidders:

3.1 The Bidder must meet all the following requirements:

- (1) The Bidder shall be an enterprise with independent legal personality, registered in the People's Republic of China and any member country of BRICS.
- (2) The Bidder shall have a valid Work Safety License issued by relevant administrative department.
- (3) The Bidder shall have valid Authentication Certificates for ISO Quality Management System, for Environmental Management System and Occupation Health Safety Management System.
- (4) The Bidder shall have good bank credit, financial status and business reputation, without being ordered to suspend business, or being in the states such as takeover, freezing of assets or bankruptcy.
- (5) The Bidder is not allowed to bid in the name of others by acquiring qualifications and certificates through transfer or lease. It is prohibited to use false or forged licenses or provide false financial statements, performance, credit status or other information.
- (6) The Bidder must have one of the following qualifications required by this bid invitation:
 - 1) Grade III qualification for general contracting of port and waterway engineering and above;
 - 2) Grade II qualification for professional contracting of port and coastal engineering and above;
 - 3) Grade II qualification for professional contracting of offshore oil engineering and above;
 - 4) Grade I qualification for general contracting of electric power engineering and above;

3.2 The Project Manager is required to: be a first-class certified constructor who is employed by the Bidder, has more than 5-year work experience in construction management and has served as the Project Manager for at least 1 offshore wind power project or offshore foundation project.

3.3 Requirements of Performance:

The Bidder shall have performance in offshore WTG erection works or offshore pile (diameter not less than 2m) foundation works. Copies of contractual performance and completion certificates issued by the owner shall be attached. Otherwise, the performance will be considered as invalid.

3.4 If the Bidder is a consortium, all the members of the consortium must satisfy the requirements in 3.1 (6) and 3.3.

3.5 The Bidder shall not have one of the following circumstances:

- (1) It has been listed in the list of enterprises with serious breach of laws and credit in the National Enterprise Credit Information Publicity System (<http://www.gsxt.gov.cn/>);
- (2) It has been listed in the list of dishonest persons subject to enforcement on "Credit China" website (<http://www.creditchina.gov.cn/>);
- (3) The Bidder, its legal representative or proposed project manager has bribery or criminal records on China Judgements Online (<http://wenshu.court.gov.cn/>) in recent three years.

When submitting the bids, the Bidder should provide a declaration to indicate the absence of the 3 circumstances above and screenshots of query results on above websites.

2.1 项目概况：

粤电阳江沙扒海上风电项目场址位于广东省阳江市阳西县沙扒镇附近海域，本期风电场场址四至坐标：111.665° E, 111.552° E, 21.339° N, 21.377° N，涉海面积约48km²。场址水深范围23m~27m，中心离岸距离约20km。

项目规划装机容量为300MW，拟布置55台单机容量为5.5MW的风机机组，同时配套建设220kV海上升压站、陆上控制中心。风电机组发出电能通过35kV集电海底电缆接入海上升压站，升压后通过2回220kV海底电缆接入陆上控制中心，并通过架空线路送到220kV汇能站。
