- 1. This Invitation for bids follows the general procurement notice for this project that appeared on the Web-site of the New Development Bank (NDB) on July 18, 2019.
- 2. The Russian Federation has received a loan from the New Development Bank towards the cost of a Development of Water Supply and Sanitation Systems Project and it intends to apply part of the proceeds of this loan to payments under the Contract No. DWSP/ICB/IVN-1 comprising of two lots: Lot 1 "Reconstruction of water treatment system at ONVS-1 (water treatment pumping station) in Avdotino" and Lot 2 "Construction of the water pipeline from Khudyninsky dam to ONVS-1 station in Avdotino".
- 3. Representative Office of the Saint-Petersburg Foundation for Investment Projects (FISP) in Moscow, acting on behalf of the Ministry of Construction, Housing and Utilities of the Russian Federation, as the Project Implementation Unit (PIU) now invites sealed bids from eligible bidders for procurement of works for reconstruction of water treatment system at ONVS-1 in Avdotino and construction of the water pipeline to it from Khudyninsky dam, which include procurement of equipment, construction and installation works, testing and commissioning of works.
- 4. Bidding will be conducted through the international competitive bidding procedures in line with the New Development Bank Procurement policy published on March 28, 2016, (revised March 31, 2017), and is open to all bidders from eligible source countries as defined in the Procurement policy.
