

**Bidding Announcement for Supervision Service of Collecting and Distributing Roads  
within Lanzhou New Area Regional Hub Multimodal Logistics and Transport Infrastructure  
Demonstration Project Financed by the New Development Bank**

**1. Bidding conditions**

Lanzhou New Area Regional Hub Multimodal Logistics and Transport Infrastructure Demonstration Project has been approved by Gansu Provincial Development and Reform Commission in the form of an document titled Supplementary Approval Regarding Adjusting Lanzhou New Area Regional Hub Multimodal Logistics and Transport Infrastructure Demonstration Project Financed by the New Development Bank (Ganfagai Foreign Fund [2019]No. 401). The project owner is Lanzhou New Area Foreign Fund Project Management Office and the fund of construction comes from the loan of the New Development Bank. The purchaser is Lanzhou New Area Foreign Fund Project Management Office and the bidding agent is China Ocean Construction International Tendering Co. Ltd. The project has met the conditions for bidding, and the project is now open for public bidding in the form of post-qualification.

**2. Project background and bidding scope**

**2.1 Construction location and scale:** The location of construction is in Lanzhou New Area. The construction scale is as follows.

- 1) Wei No.8 Road East Extension Works: the road starts from Jing No.15 Road in the west to Wei No. 1 Road in the east, with the total length up to 2762 meters;
- 2) Jing No. 7 Road North Extension Works: It starts from Huozhan North Road in the north to Jing No. 7 Road in the south, with the total length up to 9482.3 meters;
- 3) Wei No. 51 Road Works: it starts from Jing No. 1 road in the Logistics Park to Provincial Road No. 201, with the total length up to 2585 meters;
- 4) BW13 Road Works: it starts from Wei No. 53 Road in the north to Huozhan North Road in the south, with the total length up to 1400 meters;
- 5) Kedong Road Construction Works: it starts from Wei No. 16 Road in the north to Southern Urban Ring Road in the south, with the total length up to 6417.7 meters;
- 6) Ketu South Road Construction Works: it starts from Wei No.8 Road in the north to Wei No. 13 Road in the south, with the total length up to 3235.5 meters.

**2.2 Bidding scope:** The supervision service for the whole process of construction and the warranty

phase of the roads construction works within the scope of the construction drawing. The bidding is divided into one bid section, as shown in the following table:

**2.3 Service period:** 51 months (including 39 months of the construction period; delivery acceptance and defect liability period of 12 months).

### 3. Bidder qualification requirement

**3.1 Qualification requirement:** The bidding requires the bidders to have good experience, performance and reputation, and to have the capacity to perform the corresponding supervision services.

3.1.1 The bidder must have the status of an independent legal person and must hold a valid business license of the legal person issued by the industry and commerce administrative authority.

3.1.2 Domestic bidders must have a comprehensive qualification certificate for engineering supervision issued by the construction administrative authority.

3.1.3 Domestic bidders must provide a basic account opening permit.

#### 3.2 Performance requirement

In the past five years (August 1, 2014 to present), the bidder has undertaken at least two supervision contracts, being municipal road engineering supervision of not less than CNY 15 million. (Based on the bid-winning notice and the contract of supervision; the time is subject to the date of signing the contract).

#### 3.3 Financial requirement

3.3.1 The bidder has a good financial position in the past three years and no loss. Bidders are required to provide financial reports audited by accounting firms or audit institutions for the past three years (2016-2018).

3.3.2 The annual operating income of the bidders in the past three years (2016-2018) should be no less

than CNY 80 million.

3.3.3 The ratio of current assets to current liabilities of bidder for the past three years (2016-2018) should be no less than one.

### **3.4 Key personnel requirement**

3.4.1 The bidder's chief engineer must have the certificate of the national registered supervision engineer. The registered professional should be municipal utility works, with relevant professional senior technical titles. Since August 1, 2014, he or she shall undertake the municipal road supervision service with a contract amount of no less than CNY 15 million.(Based on the bid-winning notice and the contract of supervision; the time is subject to the date of signing the contract). He or she should have a letter of appointment of the chief engineer.

3.4.2 The other staff and supervisors that the bidder shall provide are detailed in the terms of reference for supervision service.

**3.5** The bidding does not accept the consortium bid.

**3.6** If the person in charge of the enterprises is the same person or different enterprises with controlling or managing relationship, they shall not participate in the bidding of the same tender section or the same tender project without dividing the tender section. Otherwise, all relevant bidders will be invalid.

**3.7** Bidders who are listed as the illegal and dishonest enterprises in the national enterprise credit information publicity system or on the website of "Credit China" (<http://www.creditChina.gov.cn/>) as the dishonest executives will be rejected to participate in the bidding; and the bidders who are listed in national enterprise credit information publicity system as serious illegal and dishonest enterprises are not allowed to participate in the bidding. In the past three years (from August 1, 2016 to August 1, 2019), bidders, their legal representatives or proposed chief engineer who have the bribery records are not allowed to participate in the bidding.

**3.8** In the past five years (2014-2018), bidders who are declared unqualified by Chinese governments at all levels, by members of the New Development Bank and other international financial organizations are not allowed to participate in bidding.

**3.9** Individuals or enterprises listed by the judicial department as dishonest persons or with other dishonest acts (including enterprise whose legal representatives, principal persons in charge, actual controllers, directors, supervisors and senior managers are listed as dishonest persons) shall be restricted to participate in government investment projects or the projects that mainly use public finance. They are restricted to engage in the development and utilization of real estate resources such as land and minerals, to participate in the transaction of state-owned property rights such as state-owned enterprises' assets and state assets, and to participate in the centralized procurement of drugs and medical consumables and the sunshine procurement activities. If a person who is dishonest participates in the transaction of public resources, the

bid evaluation committee shall disqualify him or her or cancel the bidding directly. (This project will abide by this clause, and the unfinished matters shall be interpreted by the purchaser)

#### **4. Access to the bidding documents**

**4.1** Potential bidders who intend to participate in public resources trading activities in Gansu Province need to register on the Gansu Public Resources Trading Website first. Please log in by using "user name + password + authentication code" or CA digital authentication. After that, they can download or read the bidding documents from the internet and engage in follow-up activities such as registration (for detailed information, please see bidding documents)

**4.2** All interested bidders should register online at Gansu Public Resources Exchange Bureau Website from 00:00 on August 29, 2019 to 00:00 on September 3, 2019. The deadline for online system registration is the deadline for the publication of bidding documents (or pre-qualification documents) (the publication time is  $n * 24$  hours,  $n < 5$  days for the publication of tender documents in accordance with relevant national regulations).

#### **5. Submission of the bids and other issues**

**5.1** The owner will not organize a pre-bidding meeting but the bidders are encouraged to conduct on-site survey by themselves; those who do not conduct on-site survey shall be deemed to accept the conditions of construction site.

**5.2** Deadline for submission of bids (bid-opening time): September 20, 2019, 9:00 (Beijing time). Please deliver the bids before this time.

**5.3** The place of submission of bids (bid opening place): No. 7 Bid-opening hall on the 6th floor of Gansu Public Resources Exchange Bureau  
(Address: 68 Yanxing Road, Chengguan District, Lanzhou City, Gansu Province).

**5.4** The bidder shall not be entertained if the bidding documents are overdue or not delivered to the designated place.
