

2. The Demand draft of Bid security and Bid cost or any other mode as per ITB/ITC of bid document/RFP and Bid Cost should be payable in favour of "Executive Engineer GFC&Drainage Division Hanumangarh".
3. The Bid cost of this work is Rs.5000/-
4. Separate Processing fee of Rs. 1000/- isto be paid in form of Demand Draft in favour of M.D. RISL Payable at Jaipur.
5. Scanned copy of DD's of Bid cost, processing fee and Bid security should also be uploaded along with the online Bid proposal.
6. The original DD and other documents arerequired to be submitted to the "Executive Engineer GFC&Drainage Division Hanumangarh". latest upto dated 29.11.2019, 11:00 AM. In case of any bidder fails to submit the original DD's of Bid cost, processing fee and Bid security up to prescribed date and time in aforesaid office the Bid shall not be opened and liable to be rejected.
7. The Bid not uploaded in prescribed form will be rejected without mentioning any reason.
8. All pages and schedules of original Bid and supporting documents should be essentially filled in and should be signed on each page by the Bidder/Consultant or his authorized representative.
9. Online Bid will be received and opened on dates mentioned above by the Bid evaluation committee or by an officer authorized in presence of intending Bidders or their authorized representatives.
10. Physical/offline Bid will not be accepted.
11. The Bid will be valid for 120 days from the last date of bid submission.
12. The Department reserves right to reject any or all Bids or to accept them in part, without assigning any reason thereof.
13. In case there is a Gazetted holiday declared on the date of opening of the Bid the same will be opened on next working day at same time.

15. The department shall not be liable for any delay in uploading the Bid document on website. Bidders are advised to upload Bid and all documents on or before scheduled date and time.
16. Before submitting of e-Bid, the Bidder should ensure that all the related documents have been scanned and attached with the Bid proposal.
17. Conditional Bid uploaded by the Bidder will not be accepted.

Bidders who wish to participate in the Bid will have to register on <http://eproc.rajasthan.gov.in> (Bidders registered on <http://eproc.rajasthan.gov.in> before 30.09.2011 needs to be register again to participate in online Bid. Bidders will have to procure Digital Signature Certificate(Type IIInd or Type III) as per IT Act 2000 using which they can sign their electronic Bid. Bidder can procure the same form any CCA approved Certifying Agency i.e. TDS Safe crypt. Encode etc. or they may contract e-procurement cell, Department of IT & C, GOR for further assistance. Bidder who already has a valid digital certificate need not procure a new digital certificate.
