# I. Bidding Conditions

Size: RMB 5.75 million for building and installation. 1. Project overview: In this project, the rooftops of AECC commercial aircraft engine Co., Ltd are proposed to be used for development of distributed photovoltaic power stations, crystalline silicon components will be used and grid-tie inverters will be in series, with distributed power generation and centralized grid tie. The project is addressed at No. 77, Hongyin Road, Pudong New Area, Shanghai. 2. Bidding scope. The scope of work for bidding includes but not limited to completion of relevant procedures, full construction of the project, construction management, grid tie coordination and supporting services. #### **III. Bidder Qualification**

 Have the status of an independent legal person, hold a legal person business license issued by the industrial and commercial administrative department and have the corresponding business scope;

2. Have the qualification of Grade III or above in general contracting of power engineering construction;

3. Have a work safety license; (for enterprises not in Shanghai, the work safety license must be filed in Shanghai);

4. The proposed project manager shall be equipped with the Grade II or above registered construction engineer qualification in mechanical and electrical engineering and have the valid work safety assessment certificate.

5. Undertake that the registered constructor is not involved in any project under construction in Shanghai; in case of any change in the project leader during the performance of the contract, it is not permitted to participate in the bidding of this bid section if it is less than six months after change. (The format of the letter of commitment shall be determined by the qualified bidder at its own discretion).

No joint venture tendering is permitted for this project.
