The <u>People's Republic of China</u> has received the loan from the <u>New Development Bank (NDB)</u> toward the cost of <u>Lanzhou New Area Regional Hub Multimodal Logistics and Transport Infrastructure Demonstration Project</u> and it intends to apply part of the proceeds of this loan to payments under the Contract for <u>Zhongchuanbei Station Multimodal Transportation Enhancement Works</u>.

1. <u>COC International Tendering Co. Ltd (Hereinafter referred to as 'Agent')</u> commissioned by the <u>Lanzhou New Area Foreign Fund Project Management Office</u> (Hereinafter referred to as 'Employer'), now invites sealed bids from all eligible and qualified bidders for the construction and completion of the following works.

This project consists of two parts, Zhongchuanbei station multimodal transportation facilities upgrading project - railway part (hereinafter referred to as the "station upgrading part") and Zhongchuanbei station multimodal transportation facilities upgrading project - logistics park to strengthen (hereinafter referred to as the "logistics park reinforce part").

The main project contents of the station reform: newly construct 6 arrival and departure railway lines; newly construct 1 back-turning section for Zhongchuan North Station locomotive depot;newly construct west-end pull-out line; newly construct related operation and living facilities such as the comprehensive operation building and staff's dormitory.

logistics park enhancement works: newly build 1 new metal delivery warehouse loading and unloading line, upgrade the original infrastructure, freight yard and supporting equipment; newly built packaging operation area platform warehouse; newly build large cargo operation area and commodity car operation area; carry out the yard hardening works and construct ring road; construct other other production and living facilities; newly construct road distribution warehouses, supporting facilities, and intelligent warehouses, etc.

The estimated completion period is 36 months.

- 2. Bidding will be conducted through the Member States Competitive Bidding procedures. The bidding is open to all bidders from Eligible Sources Countries as defined in the Procurement Guidelines of New Development Bank (NDB).
- 3. The attention of prospective Bidders is drawn to the eligibility and conflict of interest provisions under ITB 4 of the Bidding Documents. All Bidders found to have a conflict of interest shall be disqualified.
- 4. The bidder's eligibility requirements include:
- 1) Domestic bidders must have first-class and above qualifications for railway works, municipal public works and construction works construction general contracting at the same time issued by the State; Equivalent qualifications are needed for foreign bidders.
- 2) The bidding does not accept Joint Venture bid.
- 3) In the past three years (2017-2019), the audited financial report proved that the average annual turnover reached CNY500 million or an equivalent amount in a freely convertible currency;
- 4) The bidder's financial resources (such as quick-moving assets, credit lines and other sources of financing, excluding contractual advances) must be able to meet: (1) A cash flow requirement of CNY50 million or an equivalent amount in a freely convertible currency; (2) The total cash flow requirements required to implement this contract and other projects under construction.
- 5) The bidder shall be the contractor in the past 5 years (February 2015- February 2020) successfully undertaken at least two construction contracts of similar scale and complexity, and each contract amount is not less than CNY500 million or an equivalent amount in a freely convertible currency, based on the notice of winning the bid or the contract or completion acceptance certificate;
- 6) The project manager who participates in the project construction shall have at least 8 years of construction experience and 5 years of experience as a similar project manager in the project with the same nature and scale of the project, and have the qualification of the railway engineering first-class registered architect. Senior or above technical title. Have valid production safety examination certificate. The chief engineer of the project must have senior and above titles, and should have at least 8 years of construction experience and 3 years of experience as a chief engineer of similar projects. Equivalent qualifications are needed for project manager and chief engineer of foreign bidders.

- 5. Bids must be delivered to the address below at or before 14:30 pm, April 7, 2020. Late bids will be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend in person at the address below at 14:30 pm, April 7, 2020. All bids must be accompanied by a bid security of CNY5,000,000 or an equivalent amount in a freely convertible currency.
- 6. In the past five years (December 2014- December 2019), bidders who are declared unqualified by Chinese governments at all levels, by members of the New Development Bank and other international financial organizations recognized by NDB are not allowed to participate in bidding.
- 7. Individuals or enterprises listed by the judicial department as dishonest persons or with other dishonest acts (including enterprise whose legal representatives, principal persons in charge, actual controllers, directors, supervisors and senior managers are listed as dishonest persons) shall be restricted to participate in government investment projects or the projects that mainly use public finance. They are restricted to engage in the development and utilization of real estate resources such as land and minerals, to participate in the transaction of state-owned property rights such as state-owned enterprises' assets and state assets, and to participate in the centralized procurement of drugs and medical consumables and the sunshine procurement activities. If a person who is dishonest participates in the transaction of public resources, the bid evaluation committee shall disqualify him or her or cancel the bidding directly. (This project will abide by this clause, and the unfinished matters shall be interpreted by the purchaser)

- 2) All interested bidders should register online at Gansu Public Resources Exchange Bureau Website from <u>00:00 on March 14, 2020 to 00:00 on April 7, 2020.</u> The deadline for online system registration is the deadline for the publication of bidding documents (or pre-qualification documents) (the publication time is n * 24 hours, n < 5 days for the publication of tender documents in accordance with relevant national regulations).
- 3) Affected by the epidemic, the bid evaluation activity of "Zhongchuanbei Station Multimodal Transportation Enhancement Works" is changed to online evaluation on "public resources trading online open evaluation system in Gansu province"
