- 1. The Russian Federation has received a loan from the New Development Bank (NDB) toward the cost of Judicial System Support Project, and it intends to apply part of the proceeds of this loan to payments under the agreement resulting from this IFB: JSSP/ICB/2.7.2 "Upgrade of firewall and intrusion detection systems. Upgrade of federal datacenter's information protection system and federal datacenter certification.".
- 2. Foundation for Enterprise Restructuring and Financial Institutions Development (FER), which is authorized by Federal Bailiff Service (FBS) to conduct the bidding and subsequently sign the contract as a Payer with the selected Supplier, now invites sealed bids from eligible Bidders for upgrade of firewall and intrusion detection systems and upgrade of federal datacenter's information protection system and federal datacenter certification, including
 - Upgrade of Firewall Tools of the FBS Multiservice Telecommunications System at the Regional Level;
 - Upgrade of Firewall Tools of the FBS headquarters (Main Department, MD);
 - Upgrade of Computing Infrastructure of the MD;
 - Upgrade of the Information Security Package of the Federal Data Processing Center (FDPC);
 - Upgrade of the Backup System of the FDPC Information and Computer Systems;
 - Upgrade of the Monitoring and Control Package;
 - Upgrade of the LAN Packages;
 - Analysis of existing infrastructure related to the assignment;
 - Development of detailed design and other documentation;
 - Development of certification documentation and certification of the information security system;
 - Commissioning of the system;
 - Preparation and performance of acceptance tests;
 - Provision of warranty services.
- 3. Bidding will be conducted using the International Competitive Bidding (ICB) procedures specified in the World Bank's Guidelines: Procurement under IBRD Loans and IDA Credits, edition of January 2011, revised July 2014, and principles of NDB Procurement Policy (2018, as amended from time to time) and is open to all eligible bidders in the NDB member countries, that meet the following minimum qualification criteria:

a) Financial Capabilities

The Bidder's (single Bidder or Joint Venture) average annual turnover shall be at least USD 12 (twelve) million (or an equivalent amount in a different currency) for the last 3 years (2016 - 2018), in case data for 2019 is available, period 2017-2019 is acceptable).

If the Bidder is a Joint Venture, the average annual turnover of the Partner in charge shall be at least USD 8 (eight) million (or an equivalent amount in a different currency) for the last 3 years (2016 - 2018), in case data for 2019 is available, period 2017-2019 is acceptable). The average annual turnover of each Partner in a Joint Venture shall be at least equivalent of USD 4 (four) million for the last 3 years (2016 - 2018), in case data for 2016 - 2018, in case data for 2019 is available, period 2017-2019 is available, period 2017-2019 is available, period 2017-2019 is available, period 2017-2019 is available.

b) Specific Experience with Similar Projects

(1) The Bidder shall furnish documentary evidence to demonstrate that during the past three years (2017-2019) the Bidder must have completed contracts or completed stages of the contracts for supply and/or installation of IT equipment (servers, database systems, routers, switches, data protection hardware and software) for the total amount of at least 6 (six) million US dollars. The required experience could be demonstrated within a separate contracts or as part of the larger contracts for implementation of information system.

(2) The Bidder shall furnish documentary evidence to demonstrate that during the past three years (2017-2019) the Bidder must have completed contracts or completed stages of the contracts for supply and/or installation of data protection hardware and software for the total amount of at least 2 (two) million US dollars. The required experience could be demonstrated within a separate contracts or as part of the larger contracts for implementation of information system.

Where the Bidder is a Joint Venture, the Partner in Charge must comply with these requirements.

c) Technical (Organizational) Capacities

The Bidder (or, if the Bidder is a Joint Venture, any member of Joint Venture) or its proposed subcontractor shall have the following active licenses:

(1) FSTEC license for technical protection of confidential information for the following works and services:

- Monitoring of confidential information protection from unauthorized access and modification in informatization systems and tools.

- Certification tests and certification for compliance with requirements for information security in informatization systems and tools.

- Designing in the protected informatization systems and tools.

- Installation, assembly, testing, repair of information security tools (information security software (hardware and software), secure information processing software (hardware and software), information security control software (hardware and software)).

(2) The Federal Security Service (FSS) license for development, production and distribution of encryption (cryptographic) tools, information systems and telecommunication systems protected with the use of encryption (cryptographic) tools, for performance of works and provision of services in the field of information encryption, maintenance of encryption (cryptographic) tools, information systems and telecommunication systems protected with the use of encryption (cryptographic) tools (except where technical maintenance of encryption (cryptographic) tools, information systems and telecommunication systems protected with the use of encryption (cryptographic) tools is performed to meet the needs of the legal entity or individual entrepreneur) with regard to the following works and services:

- Assembly, installation, adjustment of encryption (cryptographic) tools, except for encryption (cryptographic) tools for fiscal data protection, developed for use in the cash register equipment, certified by the Federal Security Service of the Russian Federation.

- Assembly, installation, adjustment of information systems protected with the use of encryption (cryptographic) tools.

- Assembly, installation, adjustment of telecommunication systems protected with the use of encryption (cryptographic) tools.

- Repair and service maintenance of information systems protected with the use of encryption (cryptographic) tools.

- Repair and service maintenance of telecommunication systems protected with the use of encryption (cryptographic) tools.

- Maintenance of encryption (cryptographic) tools provided for by technical and operational documentation for these tools (except where such works are carried out to meet the needs of the legal entity or individual entrepreneur).

- Transfer (assignment) of encryption (cryptographic) tools, except for encryption (cryptographic) tools for fiscal data protection, developed for use in the control and cash register equipment, certified by the Federal Security Service of the Russian Federation.

- 6. Bids must be delivered to the address below at or before 14:00 Moscow time February 17, 2020. Bids need to be secured by a bid security. The amount of Bid Security required is USD 120,000.00 (one hundred and twenty thousand) or an equivalent amount in the currency of Bid, or an equivalent amount in a freely convertible currency or in Russian Rubles. Late bids will be rejected. Bids will be opened in the presence of Bidders' representatives who choose to attend at the address below at 14:00 Moscow time February 17, 2020.
- 7. The attention of prospective Bidders is drawn to (i) the fact that they will be required to certify in their bids that all software is either covered by a valid license or was produced by the Bidder and (ii) that violations are considered fraud, which is, among other remedies, punishable by potential blacklisting from participation in future NDB-financed procurement.
