1. The Rural Works Department over the years developed into a big and prestigious works organisation of the state Government of Bihar entrusted with the ambitious responsibility of connecting about 1.0 Lac rural habitations with populations 250 and above. This entails construction of over 1.11 Lac Km of rural roads under the centrally sponsored scheme of Pradhan Mantri Gram Sampark Yojana (PMGSY) and state sponsored Mukhya Mantri Gram Sampark Yojana (MMGSY) along with a few more state schemes.
2. The Rural Works Department has received financing from the NDB with the objective of enhancing the systems and processes of the programme which contributes to the finance of civil works expenditures, institutional strengthening which will support a technical assistance program designed to strengthen the capacity of relevant agencies to implement the program and intends to apply part of the proceeds for the aforesaid consulting services.
3. The Consultant will be required to provide sufficient technically qualified and experienced staff for providing the required level of service. Based on the information submitted by the bidder in response to this EOI, the firms would be short-listed and the short listed firms would be issued RFP for further processing.
4. Eligible firms ("Consultants") are invited to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualification and relevant experience to perform the Services.

The short listing criteria are:

- a) Past experience in carrying out the Program Management Services, Contract Management, Procurement/Transaction Advisory, Institutional/Capacity Building in roads and infrastructure sector funded by multilateral external funding agencies/central government agencies/state government agencies over the past (7) years.
- b) Annual turnover of the firm for at least the last three years. (FY 2016-17, 2017-18 & 2018-19) showing at least average annual turnover equivalent to INR 25.00 Cr.
- c) Key Professional staff qualifications & Competence for the Assignment.
- d) The bidder should not have been blacklisted/debarred/terminated/declared having dissatisfactory performance with any state/central government organization/PSU Organization/bilateral/multilateral funding agencies.

Expression of Interest shall be not more than 100 pages and must include:


- Introductory letter on letter head (with complete contact details-name of the contact person, mailing address, telephone, fax, e-mail etc.) explaining how the firm is best to deliver the task.
- Organization profile.
- Annual turn over of the firm for at least the last three years. (FY 2016-17, 2017-18 & 2018-19).
- Short note on the similar projects implemented by the firm pertaining to the short listing criteria along with the contact details of past clients.

- The EOI should contain sufficient supporting documents to substantiate the claim of the consultant towards their qualification as per the short listing criteria.
- An undertaking by the bidder should not have been blacklisted/debarred/terminated/declared having dissatisfactory performance with any state/central government organization/PSU Organization/bilateral/multilateral funding agencies.

A Consultant/firm will be selected in accordance with the (QCBS) **Quality and Cost Based Selection Method**.


