1. Bidding scope, brief description of the services and project overview

1.1 Nature of the bidding: Public bidding

1.2 Objectives and brief description of the services

The project management support consulting services will provide project

management and technical assistance to Huangshi Municipal Project Management Office (PMO) and related management departments during the construction period and fully embody NDB's six principles of "Economy, Efficiency, Value for money, Fit for purpose, Competition and Transparency" to ensure the project management in compliance with NDB's procedure requirements.

The scope of work includes the tasks listed below. Focusing on project design, bidding, quality, safety, progress, procurement, contracts, cost control, withdrawal and disbursement, the consultant shall manage and control risks, put forward arrangements on Environmental and Social aspects and ensure the smooth implementation of the project. The tasks include but not limited to: 1) project management and project performance assessment; 2) safety and social security policy implementation; 3) financial management and cost control; 4) review of bidding documents; 5) project implementation process management; 6) update and review of semi-annual reports; 7) review of annual financial reports; 8) internal environment monitoring; 9) project completion report, etc.

1.5 Project Overview and bidding scope

Project Overview:

Hubei Huangshi Modern Tram Project will upgrade urban transportation infrastructure and management services, improve transportation and living conditions of the residents in Huangshi, promote a harmonious investment environment, and enhance the city's image.

The starting point of this project is Huangshi Avenue Station and the terminal is Mineral Museum Station, with a total length of 27km approximately and 30 stations. There will be one depot - Baihua Depot and the dispatch center will be located there. The total investment of the project is around RMB 4.57 billion.

Quantity: One bid lot

Controlling bid price: RMB 8.31 million. Bid prices shall not exceed the controlling bid price.

Term of services: 48 months after the contract signing (tentative)

2. Qualification requirements of bidders

Bidders should meet the following basic requirements (bidders that do not meet the following requirements will be rejected):

2.1 This bidding is open to bidders from all NDB member countries.

- 2.2 Qualification requirements: the consultant firm/institution should hold a business license of enterprise legal person, have at least 5 years of consulting service experiences, and possess corresponding capabilities in personnel, equipment, funds, etc.
 - 2.3 Bidders in the form of joint ventures are not acceptable.
- 2.4 Consultants listed on the website of "Credit China" (www.creditchina.gov.cn) as defaulters or parties involved in major tax violations are not acceptable.
- 2.5 Consultants with the same person in charge, related in the form of holding controlling interest or having management relations shall not participate in this bidding at the same time. Relevant bids violating the above regulations will be declared as invalid bids.
- 2.6 Consultants that provide services of overall design, standard preparation, project management, supervision, testing, etc. for this project shall not participate in this bidding.
