# Invitation for Bids of the General Contracting for the Shanghai SBM, Yong en and Kalmar Distributed Photovoltaic Power Generation Project

#### I. Bidding Conditions

The cost of construction and installation is RMB 2.8 million. 1. Project overview: construction of a distributed photovoltaic power stations on roofs of factory buildings, for which crystalline silicon modules will be used, and the grid-connected inverters will be string inverters. Distributed generation and centralized grid connection will be employed. Project site: Shanghai Project capacity: 1.2MWp 2. Bid substance: including but not limited to the going through of related procedures, all constructions, construction contracting management, grid connection coordination, and supporting services. The specific bid substance, purchasing scope and requirements shall be subject to bidding document.

3. They shall have safety production license; (For non-Shanghai enterprises, the safety production licenses must be filed in Shanghai.)

4. Their proposed project managers must be registered construction engineer with qualification of grade 2 or higher in mechanical and electrical engineering, and hold valid production safety certificate.

5. They undertake that their registered construction engineers are not working for any project under construction in Shanghai, and if changes occur with respect to the project principals during the performance of the contract, and the time after the change is less than half a year, they will not participate in the bidding of this lot. 6. Have the ability to perform the contract, operate in accordance with the law, and have not been subject to legal sanctions due to the problem of good faith; Have good commercial credit and industry reputation; (Format is not specified)

7. Relevant performance since January 1, 2017; (contract)

8. The bidder shall undertake that the bid is not prohibited by the Chinese governments at all levels, NDB members and other NDB international financial organizations. (Format is not specified)
