- 9. Conditions if any to the pricing shall be mentioned in the quote.

10. Any response beyond the submission deadline date shall not be considerd unless otherwise submission deadline is extended in writing.

The purpose of this Expression Of Interest (EOI) is to allow the Vendors who we believe are capable of delivering either service and have a realistic chance of succeeding in the process to submit a response to meet the scope and requirement defined herein.

## **Rationale for issuing EOI**

The New Development Bank are looking for a Vendor who will develop an effective UI/UX web design for the proprietary NDB Electronic Document Interchange solution that allows secure on-line electronic document interchange and processing with the workflow and digital signature service built-in.

The subject of this EOI is the execution of work on a project that includes:

- User interaction designing for all user roles in the system (UX)
- Development of user interface design, including a UI-kit describing a set of design components and rules for their use. The UI-kit, developed as a result of this tender, should allow system scaling in terms of existing functionality (adding new documents and forms)

#### **Requirements for EOI participants**

- Min 5-7 years in the market with the proven relevant experience in UX/UI design
- communication (oral and written) in English
- acceptance of the standard NDB FSA/SOW templates, available once NDA is signed.
- availability of the experienced interface designers and graphic designers team in the company
- participant registration in BRICS countries
