The People's Republic of China has obtained the loan from the New Development Bank(NDB) toward the cost of Lanzhou New Area Regional Hub Multimodal Logistics and Transport Infrastructure Demonstration Project (Loan No.:19CN04) and it intends to apply part of the proceeds of this loan to the payments under the Contract for Construction of Collecting Roads, including Kedong Road and Keti Road.

1. COC International Tendering Co. Ltd(Hereinafter referred to as “agent”)delegated by Lanzhou New Area Foreign Fund Project Management Office(Hereinafter referred to as “Employer”), now invites sealed bids from all eligible and qualified bidders for the construction and completion of the following works.

The project consists of two parts, including Kedong Road and Keti Road. The road is planned to be the main road of the city, located in the southeast area of Lanzhou New Area, with a design speed of 50km/h and a total length up to 9653.193m.

Main construction content of Kedong Road: the length is 6417.702m; road red line width is 50m; the green landscape belt on both sides is 20m, with the total width up to 90m (including K4+986.178 to K6+417.702 section of the east side 20m green belt has been included in the rainwater under construction The greening range of the channel storage tank, so the total width of the road section Kedong Road is 70m),. The road is equipped with lighting, drainage, reclaimed water, greening and related auxiliary facilities. The starting point of Kedong Road is at the built Wei 16th Road, and the ending point is at the built South Expressway.

Main construction content of Keti Road: the road length is 3235.491m; the red line width is 50m, and the green landscape belts are 20m on both sides, with a total width up to 90m. The road is equipped with lighting, drainage, reclaimed water, greening and related auxiliary facilities. The starting point of Keti Road is located at Wei 8th Road, the starting point of construction is at Wei 6th East Road, and the ending point is at Wei 13th Road.

The construction period is 24 months.

The bidding will be conducted through the Member Countries Competitive Bidding procedures. The bidding is open to all bidders from Countries as defined in the Procurement Guidelines of New Development Bank (NDB).

The attention of prospective Bidders is drawn to the eligibility and conflict of interest provisions under ITB 4 of the Bidding Documents. All Bidders found to have a conflict of interest shall be disqualified.

Qualifications requirements include:

- 1) Domestic bidders must have first-class and above qualifications for municipal public works construction general contracting issued by the Ministry of Housing and Urban-Rural Development, and have a valid safety production license. Equivalent qualifications are needed for foreign bidders.
- 2) The bidding does not accept Joint Venture bid.
- 3) In the past three years (2017-2019), the audited financial report proved that the average annual turnover reached CNY500 million or an equivalent amount in a freely convertible currency. Equivalent qualifications are needed for foreign bidders.
- 4) The bidder's financial resources (such as quick-moving assets, credit lines and other sources of financing, excluding contractual advances) must be able to meet: (1) A cash flow requirement of CNY50 million or an equivalent amount in a freely convertible currency; (2) The total cash flow requirements required to implement this contract and other projects under construction. Equivalent qualifications are needed for foreign bidders.
- 5) The bidder shall be the contractors that in the past 5 years (September 2015-September 2020) have successfully undertaken at least two construction contracts of municipal arterial road, or are implementing at least two construction contracts of municipal arterial road (the construction progress shall at least complete the pavement engineering) with similar scale and complexity (The road standard is not less than 4 lanes, including pavement, rainwater, sewage, reclaimed water, and greening projects, and the number of kilometers is not less than 9.6 kilometers), and each contract

amount should be no less than CNY390 million or an equivalent amount in a freely convertible currency, based on the notice of winning the bid or the contract or completion acceptance certificate. Equivalent qualifications are needed for foreign bidders.

6) The Project Manager(PM) who participates in the project construction should have at least 8 years of construction experience and 5 years of experience as a PM in the project with the similar nature and scale, and in the past 5 years (September 2015 to September 2020), has undertaken at least one municipal road project with the single contract value is not less than the equivalent of CNY200 million. The PM should also have the qualification of the first-class registered construction engineer of municipal engineering, have senior or above technical title in engineering field, and have a valid safety production qualification certificate. The Chief Engineer(CE) of the project should have qualification of the first-class registered construction engineer of municipal engineering, have senior or above technical title in engineering field, and should have at least 8 years of construction experience and 5 years of experience as a CE in the similar projects. Equivalent qualifications are needed for project manager and chief engineer of foreign bidders.

2. All bids must be accompanied by a bid security of **CNY5,000,000** or guarantee for the equivalent amount in a freely convertible currency.

3. In the past five years (September, 2015- September, 2020), bidders who are declared unqualified by Chinese governments at all levels, by members of the New Development Bank are not allowed to participate in bidding.

4. Individuals or enterprises listed by the judicial department as dishonest persons or with other dishonest acts (including enterprise whose legal representatives, principal persons in charge, actual controllers, directors, supervisors and senior managers are listed as dishonest persons) shall be restricted to participate in government investment projects or the projects that mainly use public finance. If a person who is dishonest participates in the bidding of this contract, the bid evaluation committee shall disqualify him or her or cancel the bidding directly. (This project will abide by this clause, and anything not specified here shall be interpreted by the purchaser).

6. Access to the bidding documents

1) Potential bidders who intend to participate in public resources trading activities in Gansu Province need to register on the Gansu Public Resources Trading Website first.

Please log in by using "user name + password + authentication code" or CA digital authentication. After that, they can download or read the bidding documents from the internet and engage in follow-up activities such as registration (for detailed information, please see bidding documents)

4) Affected by the epidemic of the COVID-19, the bidding activity of Lanzhou New Area Regional Hub Multimodal Logistics and Transport Infrastructure Demonstration Project, contract for Construction of Collecting Roads, including Kedong Road and Keti Road, will be conducted through the Online Bid Evaluation System of Gansu Provincial Public Resources Trading Bureau (<http://121.41.35.55:3010/OpenTender/login>). The bidders are required to log in the system mentioned above before the bid opening time, and download following items: **bidding document curing tool, guidance of online bid evaluation system and cured bidding document**. By following the guidance of online bid evaluation system, the bidders should solidify the bid documents and complete online bidding (upload the file HASH code of the solidified bid document) and the bid opening operation. If there is without online bidding process before the bid opening deadline (upload the file HASH code of the solidified bid document), it is deemed that the bid is abandoned. **This contract adopts to "one-stage two-envelope"**.
