The People's Republic of China has obtained the loan from the <u>New Development</u> <u>Bank(NDB)</u> toward the cost of <u>Lanzhou New Area Regional Hub Multimodal</u> <u>Logistics and Transport Infrastructure Demonstration Project</u> and it intends to apply part of the proceeds of this loan to the payments under the Contract for <u>Zhongchuanbei Station Multimodal Transportation Enhancement Works.</u>

1. <u>COC International Tendering Co. Ltd</u>(Hereinafter referred to as "agent") delegated by <u>Lanzhou New Area Foreign Fund Project Management Office</u>(Hereinafter referred to as "Employer"), now invites bids from all eligible and qualified bidders for the construction and completion of the following works:

The project consists of two parts, namely, the Zhongchuanbei Station Multimodal Transportation Enhancement Works - railway part (hereinafter referred to as the "station improvement part"), and the Zhongchuanbei Station Multimodal Transportation Enhancement Works - logistics park reinforcement (hereinafter referred to as the "logistics park reinforcement part").

The main construction activities for the "station improvement part" include the following. The station is equipped with 6 new electrified arrival and departure lines on the south side, with an effective length of 1050m. One new pull-out line is to be built on the west side of the station, with an effective length of 1050m. One new engine turn-back section is to be built. In this section, there are janitorial rooms, operation and preparation buildings, crew apartments, mechanic apartment buildings, tanker storage, canteen and other production and living facilities. The station is to be equipped with loading and unloading service rooms. The total construction area of the building is 5245.59 m², and the new road in the machine section is 1685 m. The area of new ground hardening

is 23032 m². One box bridge is set up in the throat area at the west end of the station across the railway via Jing No. 1Road. (At present, part of the construction works has been completed on site. For the remaining parts, please see bill of quantities in the bidding document. Apart from the construction site, other small and temporary works will not be considered.)

The main construction activities for "logistics park reinforcement part" include the following. Newly construct one loading and unloading line (cargo line No. 11), upgrade one loading and unloading line (cargo line No. 12), with the effective length of 1050m. Expand one cargo platform ($850 \times 35 \times 1.0m$), and at the same time expand one platform canopy. Set up one warehouse on the platform, build a new park road of 2060 m, newly add 260305 m² area of ground hardening; newly build two Class-C warehouses, one fire pump room, one canteen, one freight comprehensive service building in highway logistics park, and one freight comprehensive service building in highway-railway multimodal logistics park, two air source heat pump rooms, six gates and three janitor rooms. The total house construction area is up to 41716.54 m². This project started on May 20, 2020, and stopped on August 7, 2020 for liquidation audit. The physical progress and detailed notes are provided in the Annex Supplementary Instructions in the bidding documents of Zhongchuanbei Station Multimodal Transportation Works Logistics Park Reinforcement Part._

The construction period is 30 months.

The bidding will be conducted through the Member Countries Competitive Bidding procedures. The bidding is open to all bidders from Eligible Sources Countries as defined in the Procurement Guidelines of New Development Bank (NDB).

The attention of prospective Bidders is drawn to the eligibility and conflict of interest provisions under ITB 4 of the Bidding Documents. All Bidders found to have a conflict of interest shall be disqualified.

2. The bidder's eligibility requirements include:

1) Domestic bidders must have first-class and above qualifications for railway works, municipal public works and construction works construction general contracting at the same time issued by the State; and have a valid safety production license. Equivalent qualifications are needed for foreign bidders.

2) The bidding does not accept Joint Venture bid.

3) During 2017 to 2019, the audited financial report proved that the average annual turnover reached CNY 500 million or an equivalent amount in a freely convertible currency. Equivalent qualifications are needed for foreign bidders.

4) The bidder's financial resources (such as quick-moving assets, credit lines and other sources of financing, excluding contract advances payment) must be able to meet: (1) A cash flow requirement of CNY50 million or an equivalent amount in a freely convertible currency; (2) The total cash flow requirements required to implement this contract and other projects under construction. Equivalent qualifications are needed for foreign bidders.

5) The bidder shall be the contractor in the past 5 years (January2016-January 2021)successfully undertaken at least two construction contracts of similar scale and complexity, and each contract amount should be no less than CNY 350 millionoranequivalentamountinafreelyconvertiblecurrency,basedonthenoticeofwinning thebidorthecontractorcompletionacceptancecertificate;Equivalent qualifications are needed for foreign bidders.

6) The project manager who participates in the project construction shall have at least 8 years of construction experience and 5 years of experience as a similar project manager in the project with the same nature and scale of the project, and have the qualification of the railway engineering first-class registered certification with senior or above technical title, and have a valid safety production qualification certificate while not working on other projects under construction. The chief engineer of the project must have senior and above titles while not working on other projects under construction experience and 3 years of experience as a chief engineer of similar projects. Equivalent qualifications are needed for project manager and chief engineer of foreign bidder.

3. All bids must be accompanied by a bid security of <u>CNY 5 million</u> or an equivalent amount in a freely convertible currency.

4. In the past five years (January 2016- January 2021), bidders who are declared unqualified by Chinese governments at all levels, by member countries of the New Development Bank, and by the New Development Bank are not allowed to participate in this bidding.

5. Individuals or enterprises listed by the judicial department as dishonest persons or with other dishonest acts (including enterprise whose legal representatives, principal persons in charge, actual controllers, directors, supervisors and senior managers are listed as dishonest persons) shall be restricted to participate in government investment projects or the projects that mainly use public finance. If a person who is dishonest participates in the bidding of this contract, the bid evaluation committee shall disqualify him or her or cancel the bidding directly (anything not specified here shall be interpreted by the Employer).
