5. Qualification Requirements for Bidder

5.1 The bidders shall be a legal person or other organization legally registered in any NDB member country and shall be qualified to independently sign the contract.

- 5.2 Bidders must have at least 3 (three) contract of sewage treatment plant equipment sales and installation (or guide the installation) with the contract amount no less than RMB8 million (or equivalent currency) in the last 4 (four) years.
- 5.3 The bidder shall provide the audit reports of the last 3 (three) years, shall provide the financial statements acceptable to the purchaser, reflecting the bidder's financial position, if not required by the laws of the bidder's country. As a minimum requirement, the bidder shall meet:
 - 1) The net assets of each of the last 3 (three) year are all positive, and the minimum annual average turnover is not less than CNY 21million or equivalent currency;
 - 2) The financial resources of the bidder shall meet the cash flow requirement of not less than RMB5 million or equivalent currency;
- 5.4 Before the bid deadline, the total amount of all pending lawsuits shall not exceed 50% of the bidder's net assets, and all pending lawsuits shall be counted according to the bidder's loss.
- 5.5 The project does not accept the form of a joint venture.
