1. Introduction

New Development Bank (NDB) requires enterprise level of email archive solution with high availability and flexible features to meet business need and audit requirements. Please feedback the quotation according to the requirements in this document.

2. Specifications

- Implement archive system for 350 accounts. The limit of maximum number of users should exceed 2500.
- Email archive product should be compatible seamlessly with Office 365 China version.
- Emails are archived to the archive system and searchable in seconds.
- Emails are permanently stored in storage or data center in scope of NDB's member countries, including Brazil, Russia, India, China, and South Africa.
- Migrate the in-place email data (in multiple tera bytes) and the email system should be able to ingest emails in PST or EML format from the existing email archive system.
- Support users to access this archive platform via web browser.
- Email archive system provides separate roles such as administrator, auditor and ordinary users for management, audit, and analysis purposes.
- All data is stored and exported in native format, including showing meta-data such as the sender, receiver, including blind copy recipients, time etc.



- Support disaster recovery to guarantee that the archive service keeps high continuity.
- Support email legal hold.
- Admin audit log is required.
- Integration with internal AD and single sign on with multiple factor authentication is required.
- Support archiving and recovering emails encrypted by Azure Rights Management.
- The product should have industry proven customer use case, preferrable in large financial, government or multilateral institutes.
- Reasonably high compression rate of email content and attachment into the archving system.
- Support of Office 365 encrypted emails.
- Support the deployment in multiple cloud infrastructures, including Alibaba cloud and Microsoft Azure (China and Global version).
