1. The People's Republic of China has received a loan from New Development Bank (NDB)

toward the cost of Lanzhou New Area Regional Hub Multimodal Logistics and Transport

Infrastructure Demonstration Project and it intends to apply part of the proceeds of this loan to the

payments under the Contract for the Zhongchuanbei Station Multimodal Transport Facilities

Upgrade Works, and Gaojiazhuang Station Multimodal Transport Reconstruction and Expansion

Works-Goods Procurement (Shunting diesel locomotives).

2. COC International Construction Consulting Group Co. Ltd. (Hereinafter referred to as

"Agent"), commissioned by the Lanzhou New Area Foreign Fund Project Management Office

(Hereinafter referred to as "Employer"), now invites sealed bids from all eligible and qualified

bidders for the procurement of following goods and relevant services:

Two shunting diesel locomotives. They are used for shunting and district transfer works.

(The shunting diesel locomotives should comply with GB146.1-83 "Standard Gauge Railway

Locomotive and Rolling Stock Limits" (rolling stock gage-1A, and rolling stock gage-1B). The

track gauge should be 1435mm and the power should be 1880kW. The axle type of the

locomotives should be Co-Co. Please refer to Chapter 6 of the tender documents for details

regarding technical parameters for the locomotive).

The estimated delivery time of above goods and related service is 8 months after signing the

contract.

- 3. The bidding will be conducted through the Member Country Competitive Bidding procedures. The bidding is open to all bidders from Eligible Sources Countries as defined in the Procurement Guidelines of New Development Bank (NDB).
- 4. The attention of prospective Bidders is drawn to the eligibility and conflict of interest provisions under ITB 4 of the Bidding Documents. All Bidders found to have a conflict of interest shall be disqualified.
  - 5. The bidder's eligibility requirements include:
- 1) Bidders must be manufacturers. All goods must be produced and supplied by the bidders themselves. The equipment parameters provided by the foreign bidders shall be consistent with the domestic technical parameters and standards. The non-manufacturers are not allowed to participate in the tender.
- 2) The bidder shall have the ability to perform maintenance and after-sales services such as maintenance, repair and spare parts supply, which shall be undertaken by the seller as stipulated in the contract and technical specifications. If the bidder has a maintenance or after-sales service center in the project location, the proof about the office space is needed; if an agent is designated to provide maintenance and after-sales service in the project location, the bidder shall provide the supporting documents such as the administrative license of railroad rolling stock maintenance, authorization certificate, etc. Failure to provide the required documentary evidence will result in the bidder's bid being rejected directly without an opportunity for clarification.
- 3) The bidder must be a legal person formally registered in a member country of the New Development Bank (China, India, Brazil, Russia or South Africa) and has valid independent legal person qualification (domestic bidders from China must provide a scanned copy of the business license). Failure to provide the required documentary evidence will result in the bidder's bid being rejected directly without an opportunity for clarification.
- 4) Chinese bidders shall have the administrative license of railway rolling stock production (manufacturing) orrelevantdocumentaryevidence and railway rolling stock maintenance administrative license with respect to the corresponding model issued by the State Railway Bureau orrelevant documentary evidence. Foreign bidders must have equivalent qualifications (the approved

qualification administrative license documents should be color scanned copy in the biding documents). Failure to provide the required documentary evidence will result in the bidder's bid being rejected directly without an opportunity for clarification.

- 5) The minimum guarantee of after-sales service provided by the bidder shall not be less than 24months, and a letter of commitment shall be provided. Failure to provide the letter of commitment will result in the bidder's bid being rejected directly without an opportunity for clarification.
- 6) Within the past five years (April 2016 April 2021), the bidder shall have completed at least one domestic sale performance in China with the similar scale in relation to "shunting diesel locomotives" to be procured (foreign bidders must meet the same requirement). Failure to provide the required documentary evidence will result in the bidder's bid being rejected directly without an opportunity for clarification.
- 7) The yearly cumulative business turnover of the bidder in the past 3 years (2018-2020) should be no less than CNY 0.5billion. The bidder shall provide complete financial audit report for 2018-2019 (including audited statements and notes), complete financial audit report for 2020 (including audited statements and notes) or unaudited financial report signed by the company's legal person and financial officer. Failure to provide the financial statements will result in the bidder's bid being rejected directly without an opportunity for clarification.
  - 8) This tender does not accept bids from consortium.

Detailed information on qualification requirements will be provided in the tender documents.

- 6. All bids must be accompanied by a bid security of <u>CNY 364,000 (three hundred and</u> sixty four thousand Chinese yuan only), or foreign currency in equivalent amount.
- 7. In the past five years (From April 2016 to the date of publication of the announcement of bidding), bidders who are declared unqualified by Chinese governments at all levels or by membership countries of the New Development Bank are not allowed to participate in the bidding. The bidders are required to provide certification materials or commitments, promising having not been sanctioned in the past five years. Failure to provide certification or commitments will result in the bidder's bid being rejected directly without an opportunity for clarification.

8. Individuals or enterprises listed by the relevant department as dishonest persons or with

other dishonest acts (including enterprise whose legal representatives, principal persons in charge,

actual controllers, directors, supervisors and senior managers are listed as dishonest persons) shall

be restricted to participate in government investment projects or the projects that mainly use

public finance. Provide certification materials or commitments, failure to provide certification

materials or commitments will result in the bidder's bid being rejected directly without an

opportunity for clarification. If a person who is dishonest participates in the bidding of this

contract, the bid evaluation committee shall disqualify him or her or cancel the bidding directly.
