## Hubei Huangshi Modern Tram Project Financed by NDB Loan

# Maintenance Equipment Procurement and Installation (Contract No. SI-05)

#### 1. Conditions for Tender

The Government of China has applied for use of New Development Bank (NDB) loan for Hubei Huangshi Modern Tram Project (Loan No. 19N05). This tender is open to eligible bidders in NDB member countries.

This tender for the maintenance equipment procurement and installation (SI-05) pertaining to Hubei Huangshi Modern Tram Project has been approved by the <u>Hubei Huangshi Municipality</u>, and the tenderee is <u>Huangshi Railway Construction and Investment Co., Ltd.</u> Now the conditions for this tender are ready, and an open bid for the construction is hereby invited.

## 2. Name of Project and Scope of Tender

- 2.1 Name of Project: maintenance equipment procurement and installation of Hubei Huangshi Modern Tram Project financed by NDB loan
- 2.2 Location of Project: Huangshi City, Hubei Province
- 2.3 Scale of Project: start point being Huangshi Avenue up to Mining Museum, with total length of 27km, 30 stations, and one depot at Baihua Road, where dispatching center is located. The ceiling value for the bid is <u>RMB 9742383 yuan</u>.
- 2.4 Source of Financing: NDB loan
- 2.5 Supply period: The construction period for this lot is tentatively set at 30 calendar days, with a defect liability period of 24 months.
- 2.6 Scope of Tender: Please see the bill of quantities for details.

### 3. Bidders' Qualification Requirement

- 3.1 Eligibility requirement: This tender is open to all bidders registered in the NDB member countries, and bidders from NDB member countries with corresponding capabilities are eligible to participate in bidding.
- 3.2 Financial requirement: Bidders must provide financial audit reports for the past two years (referring to financial accounting statements audited by accounting firms or auditing institutions for the years 2021 and 2022, at least including copies of balance sheets, cash flow statements, income statements, and financial statements), and the operating profits for the past two years should be greater than 0. Bidders from member countries of the NDB other than the People's Republic of China are not required to provide the aforementioned financial statements.

3.3 Performance of Bidders: Bidders are required to provide performance evidence of contracts for similar equipment since January 1, 2019 (similar equipment refers to the depot process equipment used in the urban rail transit industry (subway, light rail, tram, etc.) (The date of the contract shall prevail, and the bid-winning notice and contract agreement shall be provided.)

## 3.4 Credibility requirements:

The bidder from within P. R. China has not been listed in untrusted person on CreditChina (www.creditchina.gov.cn); the bidder from outside of P. R. China has not been prohibited to bid by governments at all levels of its own country.

- ① Bidders must provide the following commitments: a. Important content in the bidding documents is not false or falsified; b. The bidder is not in a state of suspension of business, disqualification from bidding, or property takeover, freezing, or bankruptcy; c. The bidder is not being suspended from bidding by relevant authorities and it is still within the suspension period due to fraudulent bid winning, serious breach of contract, or major engineering quality or safety production accidents, and other issues; ② If there are any of the following situations between bidders, they shall not participate in bidding for the same lot: a. The legal representatives of two or more companies are the same person; b. The relationship between the group company and its whollyowned or controlling subsidiaries (including situations of direct and indirect control); c. Bidders shall not be included in the list of dishonest persons subject to enforcement, and the situation of dishonest persons subject to enforcement shall be subject to the query results on the "Credit China" website (list of seriously dishonest entities).
- 3.5 This tender does not accept bids in consortium.
- 3.6 The bidder must provide a commitment to ensure that the supply period and quality fully meet the requirements of the technical specifications, and failure to provide such commitment will result in the rejection of the bid.

## 4. Tender Registration

This tender does not require a prior registration.

### 5. Access to Bidding Documents

Bidders who are interested to bid can download the bidding documents on the frontpage of the website of China International Engineering Consulting Co., Ltd (www.ciecc.com.cn) from 23 January 2024 to 22 February 2024. The project does not require a prior registration or payment of any document fees, and bidders can directly submit bids before the deadline.

- 6.2 Bidders within the territory of the People's Republic of China are requested to submit

their bids directly to the bid opening location on the bid opening date.

Bidders from the NDB member countries other than the People's Republic of China can send all encrypted electronic bids documents to the email address <a href="mailto:2284207921@qq.com">2284207921@qq.com</a> before the deadline for bid submission. Then, bidders should send the passwords of the electronic bids documents to the same email address from 9:00 (Beijing time) to 9:30 (Beijing time) on the day of bid opening. Bidders who only use electronic bids documents shall sign and stamp the documents in accordance with the requirements of the bidding documents, and scan them into PDF format.

6.3 Bids submitted after the deadline or not submitted to the designated venue shall be rejected.
