SECTION 1

- 1 The Bidder may submit bids for any number of the work Packages. Bidders are advised to note the minimum qualification criteria specified in Clause 4 of the Instructions to qualify for the award of the contract and also inspect the site before bidding.

- 3 If the size of the package is greater than 10 Crore then Construction / Time of completion shall be enhanced from 12 Months to 18 Months.
