## 3. Qualification Requirements for Bidder

- 3.1 shall be a charging pile manufacturer with independent legal status, bid from agent is not allowed;
- 3.2 shall be registered in NDB member countries and has not been prohibited to bid by governments at all levels of NDB member countries;

- 3.3 in past 3 years (2018-2020), the bidder's net assets of each year shall be positive, and shall be no less than CNY 90 million or equivalent foreign currency;
- 3.4 in past 3 years (2018-2020), the bidder's annual turnover shall be no less than CNY 220 million or equivalent foreign currency;
- 3.5 from Jan 2018 to the deadline for bid submission, shall at least have 1 similar charging pile experience which shall fulfill one of the following requirements:
- 3.5.1 Similar charging pile experience with a total supply power of no less than 24000kw under an individual contract (non framework agreement);
- 3.5.2 Similar charging pile experience with a total contract price of no less than CNY 60 million or equivalent foreign currency under an individual contract (non framework agreement);
- 3.5.3 Similar charging pile experience with a total number for 120kw integrated DC charging piles of no less than 200 set under an individual contract (non framework agreement);
- 3.6 from Jan 2018 to the deadline for bid submission, shall at least have 1 construction and installation experience of equipment and facilities including box transformer and distribution room (the Bidder without such experience is allowed to subcontract the installation work under this contract to sub-contractor with such experience);
- 3.7 the bidder from within P.R. China, has not been listed in untrusted person on CreditChina (<a href="www.creditchina.gov.cn">www.creditchina.gov.cn</a>); the bidder from outside of P.R. China has not been prohibited to bid by governments at all levels of its own country;
