The People' s Republic of China (hereinafter called "Borrower") has obtained financing from the New Development Bank (the "Bank") in the form of a loan (hereinafter called loan) toward the cost of Lanzhou New Area Regional Hub Multimodal Logistics and Transport Infrastructure Demonstration Project.
