Invitation for bid of Package No.W-08, W-09, W-10, W-11 & W-12 Under Reconstruction Engineering of Road S358 (Qingyang to Hongshi)

1. General

The Government of the People's Republic of China has received the loan from the New Development Bank (hereinafter refer as "NDB"), toward the cost of Loan No.: 21CN03 Anhui Highway Development Project and it intends to apply part of the proceeds of this loan to payments under the Contract for Reconstruction Engineering of Road S358 (Qingyang to Hongshi).

China International Tendering Co., Ltd. (hereinafter refer as Tendering Agency--"TA") authorized by and on behalf of Chizhou Highway Management Service Center (hereinafter refer as "Employer") invites electronic bids from all eligible and qualified bidders for the construction and completion of above mentioned Engineering, Detail as below:

2. Description of Works

The construction site of this project is located in Chizhou City, Anhui Province. The purchase scope covers all the items listed in the construction drawings and the bill of quantities. The description or work, estimated construction period, the Engineering's Estimated Value and contents of each Package are as follows :

W-10	Secondary road - Meijie Town - Meicun Town, Guichi District (K25+385-K45+ 700) , 20.315 kilometers long, asphalt concrete pavement. The roadbed is 10 meters wide and has a designed speed of 60 kilometers per hour. W-11	Secondary road - Meicun Town, Guichi District (K45+700-K73+940) , 28.24 km in length, asphalt concrete pavement. The roadbed is 10 meters wide and has a speed of 60 kilometers per hour. W-12	Secondary road - Xiaohe Town, Shitai County (K73+940-K83+868.259) , 9.928 km in length, asphalt concrete pavement. The roadbed is 10 meters wide, and the design speed is 60 kilometers per hour. 3. Qualification Requirements

3.1 The qualifications and experiences of the Bidder shall meet the requirements of personnel, equipment, financial status & etc. that suitable for Contract performance, detail as follows:

1. All Bidders under each package shall have independent legal personaality, and holding Certification of “Highway engineering construction general contracting” Grade I or above issued by the Ministry of Housing and Urban-Rural Development, and Work safety License (within validity period). Additionally, bidders who participate in Package No.: W-08 and Package No.: W-10 shall also have “Housing construction or municipal construction Engineer certificate” Grade II or above.

2. Experience:

For bidders who participate in Package No.: W-08, Package No.: W-09 and Package No.: W-12: Within last 5 years (from January 1st, 2017 to date of bid submission, subject to the issuing date of Final Acceptance) shall have completed at least: (1) One contract of new-built or rebuilt highway Grade II with a length of no less than 10 km; **or** (2) One contract of new-built or rebuilt highway Grade I with a length of no less than 5 km;

For bidders who participate in Package No.: W-10 and Package No.: W-11: Within last 5 years (from January 1st, 2017 to date of bid submission, subject to the issuing date of Final Acceptance) shall have completed at least: (1) One contract of new-built or rebuilt highway Grade II with a length of no less than 20 km; **or** (2) One contract of new-built or rebuilt highway Grade I with a length of no less than 10 km;

The total Contract Value of each of Above mentioned Contract submitted under Package No. W-08, Package No. W-09, Package No. W-10 and Package No. W-11 should not be less than CNY200 million.

The total Contract Value of each of Above mentioned Contract submitted under Package No. W-12 should not be less than CNY100 million.

For bidders who participate in Package No.: W-08 and Package No.: W-10: Within last 5 years (since January 1st, 2017) shall have completed at least 1 Contract of tunnel construction engineering, the total length of a single tunnel should not less than 1,000 meters.

3.Project Manager:

- 1)The project manager proposed under each package shall have Certificate of

“National certified Constructor Professional level One of Road Engineering” and “Examination Certificate B of Work Safety” issued by provincial or above transportation department.

2) For project manager proposed under Package No.: W-08, Package No. W-09 and Package No.: W-12: Within last 5 years (from January 1st, 2017 to date of bid submission, subject to the issuing date of Final Acceptance) shall have conducted as project manager at least: (1) One contract of new-built or rebuilt highway Grade II with a length of no less than 10 km; **or** (2) One contract of new-built or rebuilt highway Grade I with a length of no less than 5 km;

3) For project manager proposed under Package No.: W-10 and Package No.: W-11: Within last 5 years (from January 1st, 2017 to date of bid submission, subject to the issuing date of Final Acceptance) shall have conducted as project manager at least: (1) One contract of new-built or rebuilt highway Grade II with a length of no less than 20 km; **or** (2) One contract of new-built or rebuilt highway Grade I with a length of no less than 10 km;

4) The total Contract Value of each of Above mentioned Contract submitted under Package No. W-08, Package No. W-09, Package No. W-10 and Package No. W-11 should not less than CNY200 million.

The total Contract Value of each of Above mentioned Contract submitted under Package No. W-12 should not less than CNY100 million. The construction of each of Above mentioned Contract should include roadbed or pavement works.

5) The proposed project manager for each packages shall not serve as the project manager of other projects on date of bid submission. Otherwise, he/she would be to promoted and leaving the said job from any other project.

6) Additionally, the proposed project manager under Package No.: W-08 and Package No.: W-10: Within last 5 years (from January 1st, 2017 to date of bid submission, subject to the issuing date of Final Acceptance) shall have conducted as project manager at least 1 Contract of tunnel construction engineering, the total length of a single tunnel should not less than 1,000 meters.

4. Technical Director

1) The Technical Director proposed under each package shall have Senior or above Professional Title of Road Engineering.

2) For technical director proposed under Package No.: W-08, Package No. W-09 and Package No.: W-12: Within last 5 years (from January 1st, 2017 to date of bid submission, subject to the issuing date of Final Acceptance) shall have conducted as technical director at least: (1) One contract of new-built or rebuilt highway Grade II with a length of no less than 10 km; **or** (2) One contract of new-built or rebuilt highway Grade I with a length of no less than 5 km;

3) For technical director proposed under Package No.: W-10 and Package No.: W-11: Within last 5 years (from January 1st, 2017 to date of bid submission, subject to the issuing date of Final Acceptance) shall have conducted as technical director at least: (1) One contract of new-built or rebuilt highway Grade II with a length of no less than 20 km; **or** (2) One contract of new-built or rebuilt highway Grade I with a length of no less than 10 km;

4) The total Contract Value of each of Above mentioned Contract submitted under Package No. W-08, Package No. W-09, Package No. W-10 and Package No. W-11

should not less than CNY200 million.

The total Contract Value of each of Above mentioned Contract submitted under Package No. W-12 should not less than CNY100 million.

5) Additionally, the proposed technical director under Package No.: W-08 and Package No.: W-10: Within last 5 years (from January 1st, 2017 to date of bid submission, subject to the issuing date of Final Acceptance) shall have conducted as technical director at least 1 Contract of tunnel construction engineering, the total length of a single tunnel should not less than 1,000 meters.

The proof documents for each of the Contract submitted under the request of experience as mentioned in above Clause 2, 3, and 4 shall include: 1) scanned copies of <Letter of Contract Award>, <Contract Documentation>, <Final Acceptance>; and 2) Screenshots of “Experience Information” downloaded from National Highway Construction Market Credit Information Management System (<http://glxy.mot.gov.cn>). Web screenshots shall specify the online search path for obtaining the screenshots. If all of the above-mentioned documents cannot prove the conformity of experience in detail, the bidder shall also provide documents describing the characteristics of the works, including the Bill of Quantities under the contract. The completion date of each Contract shall be subjected to the issuing date of Final Acceptance.

5. Financial Standing

- 1) Minimum average annual turnover of CNY3,000,000,000 for the last 3 years (2018, 2019 and 2020).
- 2) The bidder shall provide Letter of Reference issued by the commercial bank (state-owned or joint-stock bank at sub-branch level or above), indicating that a special line of credit or banking facility were obtained by the bidder for the execution of this Contract which not less than CNY10,000,000.
- 3) Please refer to the bidding documents for detail requirements of relevant proof documents.

6. Eligibility —None of the following bidders will be accepted.

- 1) listed in the Chinese Court as executors of dishonesty.
- 2) Listed in the abnormal enterprise operation list by the market supervision and regulation department.
- 3) Listed in major tax violation cases by tax authorities.
- 4) The bidder shall not be confirmed and published as “Occurrence of ‘larger’ or more serious safety production accidents” and/or “Occurrence of ‘common’ or more serious quality accidents” by Government authorities during the period of recent 2 years (since May 1st, 2020 to bid submission date and based on the notification of government departments).
- 5) Blacklist of wage arrears for migrant workers by Ministry of Human Resources and Social Security. Section
- 6) Restricted for bidding due to the cases of violation of Chinese law.

7. Other requirements :The bidder shall have corresponding abilities in general personnel and equipment. Please refer to the bidding documents for specific requirements.

8. Bidders are requested to log in the list of qualified enterprises for highway construction in the National Highway Construction Market Credit Information Management System (<http://glxy.mot.gov.cn>) and confirm that the information in the list is completely accurate.

3.2 Joint Venture, Consortium or Association were not acceptable.

3.3 The bidder could select one or more or total 5 packages to bid for. However, each

bidder could be awarded the Contract only under one package.

The bids will be opened and evaluated by BEC under each package separately from Package No. W-08 to Package No. W-12.

For each package, as the result of bid evaluation, there will be 1-3 candidates for award Contract at the ranking of First, Second and Third.

For each bidder who had been deemed as first rank candidate under any one of the package by the BEC, his bid/bids submitted to all other packages would be rejected.

3.4 Bidders must strictly avoid conflicts with other assignments or their own interests, and act without consideration for future work. Bidders found to have a conflict of interest shall be disqualified. Different units with the same person in charge or holding or managing relationship shall not participate in the same bidding section; otherwise, the bids shall be deemed invalid.

3.5 The bidder in the "credit" China website (<http://www.creditchina.gov.cn/>) was faithless person subjected to execution list, is not accepted.

4. Obtain BD

Bidding documents are available online on e-procurement of Public Resource Trading Center in Hefei (<http://ggzy.hefei.gov.cn/>) from July 20th, 2022 to July 27th, 2022 (at pm12:00 set automatically by E-System) for free. Bidders will be required to register on the website, a digital signature certificate compatible with the E-Procurement System (hereinafter refer as "CA Certificate") is required for first login. The Employer and/or TA will assist the foreign entities for obtaining above mentioned "CA Certificate".

5. Method of Bid Submission

Bids must be submitted online on e-procurement of Public Resource Trading Center in Hefei (<http://ggzy.hefei.gov.cn/>) on or before the 9 hours of August 9th, 2022.
