- 1. The People's Republic of China has received the loan from New Development Bank (NDB) toward the cost of Zhejiang Green Urban Infrastructure Development Project Shengzhou City Urban and Rural Water Supply and Drainage Integration Project (Phase II) and it intends to apply part of the proceeds of this loan to payments under the contract for No.3 WTP and Water Supply Pipelines Works. Bidding is open to eligible bidders from member countries of NDB.
- 2. CITIC International Tendering Co., Ltd. (hereinafter referred to as "Tendering Agent"), authorized by Shengzhou Water Group Co., Ltd. (hereinafter referred to as "Employer"), now invites sealed bids from all eligible and qualified bidders for the following works. The capital source of this project is loan of NDB:
 - 1. Contract No.: SZ-CW-8
 - 2. Name: No.3 WTP and Water Supply Pipelines Works
 - 3. Source of fund: Loan of NDB4. Description of Major Works:
 - (1) Plant station project:to build a new No.3 water plant, with a total construction area of 28,800 m². The water supply project scale is 60,000 tons per day. The plant site is located in Gangshan village, Sanjiang Street. Coagulation, sedimentation, filtration and disinfection processes are used in the water plant. It includes the construction of new buildings, auxiliary facilities and civil engineering of auxiliary roads, etc. (excluding equipment installation);
 - (2) Water transmission and distribution pipeline project: the planned construction of DN1600-DN1800 raw water conveying pipe (the pipeline starts from Changzhao Reservoir in Xinchang County and ends at Dishan Pump Station, which is contracted by the County and not within the scope of this project) lead out a raw water pipeline with length of 16.3 km pipeand DN1000 diameter connected to to No.3 WTP. After the raw water is processed by the water plant, a 2.4-kilometer long water delivery pipe with a diameter of DN1000 will be constructed to be transported to the vicinity of Ruanmiao Gas Station in Shengzhou on Yanxing Road to connect with the existing urban water supply pipe. The construction of the raw water pipeline crosses Shengzhou City and Xinchang County, and the construction of the water pipeline is in Shengzhou City.
 - (3) The raw water pipeline consists of two tunnels totaling 2960 meters, of which the design elevation of the entrance No.1 tunnel is 58.46 meters, the design elevation of the exit is 88.02 meters and the length is 915 meters; the design elevation of the entrance of No. 2 tunnel is 77.98 meters, and the design elevation of the exit is 70.72 meters, and the length is 2045 meters.; the tunnel clearance design is a gate-shaped tunnel with a clear width of 2.8 meters and a clear height of 3.1 meters.

The Bidder shall provide but not limited to the accessories required for scope of works. For specific engineering contents, please refer to the bill of quantities (Volume II of bidding document) and construction drawings for details.

- 5. Construction Period: 24 months.
- 3. Bidding will be conducted through the Open Competitive Bidding procedures. The bidding is open to all eligible bidders in accordance with Chinese relevant bidding laws and regulations and the Procurement Policy of NDB.
- 4. Interested eligible bidders may obtain further information from the contact information listed as below and inspect the Bidding Documents from April 16, 2021 to May 6, 2021, 9:00 a.m.~11:30 a.m; 1:00 a.m.~5 p.m. (except weekends and public holidays).
- 5. The attention of prospective Bidders is drawn to the eligibility and conflict of interest provisions under ITB 4 of the Bidding Documents. All Bidders found to have a conflict of interest shall be disqualified.
- 6. Bidders shall meet the following qualification requirements; detailed information is provided in the Bidding Documents:

(1) Qualification Certificate Requirements:

The bidder shall possess valid:

- ① the Grade I or above level of Qualification Certificate for General Contracting of Municipal Public Construction; and
- 2 the Work Safety Certificate.

Bidders registered in other member countries (except China) must provide relevant equivalent certificates from equivalent authority. Along with documentary evidence of registration, bidders need to provide an undertaking that the certificate holds in their country are of equal importance as Chinese authorities and at any time while authenticating the submit certificate (by prospective bidders), if some misrepresentation or false declaration is found, The Employer is free to take any punitive action not limited to just cancellation of award, forfeiture of bid security, debarment from future participation or as deemed fit by the Employer.

(2) Historical Financial Performance:

The bidder shall submit the audited balance sheets for 2017, 2018 and 2019 to demonstrate the current soundness of the bidder's financial position and its prospective long term profitability. As a minimum, a Bidder's net worth for each of the three year 2017, 2018 and 2019 calculated as the difference between total assets and total liabilities should be positive.

(3) Average Annual Construction Turnover:

The bidder shall demonstrate their minimum average annual turnover of RMB150 million, calculated as total certified payments received for contracts in progress or completed, within 2017, 2018 and 2019.

(4) Financial Resources:

The Bidder shall demonstrate access to, or availability of, financial resources such as liquid assets, lines of credit, and other financial means, other than any contractual advance

payments to meet: the cash-flow requirement of RMB30 million + the overall cash flow requirements for this contract and its concurrent commitments.

(5) Specific Experience Requirement:

- 1) From January to present (the completion (acceptance) date shall prevail), the bidder shall prove its participation as contractor or management contractor, in at least one (1) water plant or sewage treatment plant construction contract with a scale of no less than 50,000 tons per day (civil engineering must be included in the contract) that has been successfully completed.
- 2) From January to present (the completion (acceptance) date shall prevail), the bidder shall prove its participation as contractor or management contractor, in one (1) water supply network construction contract with diameter no less than DN800 and the pipe length shall be no less than 500m that has been successfully completed.
- 3) From January to present (the completion (acceptance) date shall prevail), the bidder shall prove its participation as contractor or management contractor, in at least one (1) tunnel construction contract with sectional area no less than 6m² that has been successfully completed; or, From January to present (the completion (acceptance) date shall prevail), the proposed Project Manager of the bidder has successfully completed one (1) tunnel construction contract with sectional area no less than 6m².
- 4) All (1), (2), and (3) shall be met at the same time.

(6) Qualification of Project Manager (PM):

- 1) The PM shall possess First Class Constructor in Municipal Public Works; the Employer marked on the registration certificate must be the Bidder, which the Bidder shall provide social security certificate as proof.
- 2) The PM has valid Safety Production Assessment Certificate (B certificate);
- 3) The PM shall not be the project manager of other construction projects that haven't passed the acceptance.

(7) Other Requirements:

- 1) At the time of bid submission and before contract award:
 - (1) the bidder shall not be listed in www.creditchina.gov.cn as "Discredit Entity Subject to Enforcement for Default" and shall not be listed in "National Enterprise Credit Information Publicity System" as "Discredit Enterprises with Serious Law Violation Practice";
 - (2) the bidder shall not be declared as ineligible by New Development Bank membership country.
- 2) Joint Venture is not accepted for this project. For other detailed information, please see the bidding documents.
- 7. Bids must be delivered to the address below at or before 09:00 a.m. May 7, 2021. Late bids will be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend in person at the address below at 09:00 a.m. May 7, 2021. All bids must be accompanied by a bid security of CNY 500,000 as specified in the bidding documents.
