

# Invitation for Bids (IFB)

**Project Name:** New Development Bank Funded Zhejiang Green Urban Project — Shengzhou Urban and Rural Integrated Water Supply and Sanitation Project (Phase II) — Construction, Equipment Supply, Installation and Commissioning of Fuxi Water Treatment Plant and Assorted Pipelines

1. The People's Republic of China has received the loan from New Development Bank toward the cost of Zhejiang Green Urban Project— Shengzhou Urban and Rural Integrated Water Supply and Sanitation Project (Phase II) and it intends to apply part of the proceeds of this loan to payments under the contract for Construction, Equipment Supply, Installation and Commissioning of Fuxi Water Treatment Plant and Assorted Pipelines. Bidding is open to eligible bidders from member countries of NDB.
2. CITIC International Tendering Co., Ltd. (hereinafter referred to as “the Tendering Agent”), authorized by Shengzhou Water Group Co., Ltd. (hereinafter referred to as “the Employer”), now invites sealed bids from all eligible and qualified bidders for the following Contract:

Source of Funds	New Development Bank
Scope of Supply	The main contents include: building a new water treatment plant with the scale of 15,000 cubic meters per day, with a total construction area of 14.4 mu and, located in Fuxi New Village, Chongren Town, Shengzhou. The construction content includes two parts: (1) Plant area: new construction (structures) buildings, auxiliary facilities, auxiliary road construction, equipment procurement, installation and commissioning (including equipment and processing commissioning); (2) The project of water transmission and distribution pipeline: In section A (reservoir to water treatment plant), two new DN500 raw water transmission pipelines will be built, one will be connected from Bantou Reservoir and laid along Shangzhu Line and Puxi Line to Fuxi Water Treatment Plant; and the other raw water transmission pipeline will be reserved for the planned reservoir, with a pipe length of about 13.4 kilometers. A new

	<p>DN600 water distribution pipeline will be built in Section B (water treatment plant to Chongren River), which is laid from Fuxi WTP to the left bank of Chongren River, with a pipe length of about 8.3 kilometers; In section C (water treatment plant to Shihuang Town), a new DN500 water distribution pipeline will be laid from Fuxi WTP to Shihuang Town, with a pipe length of about 5.6 kilometers. The water supply pipe connection from Fuxi WTP to this new water treatment plant and the auxiliary fittings such as pipes and valves for the equipment in the structure, all electrical, automatic control, instrumentation and monitoring equipment and button boxes, as well as cables and optical cables for equipment connection, and laying lines, slots and steel pipes are all supplied and installed by the equipment unit within the scope of this tender.</p> <p>The bidder shall provide but not limited to the accessories required within the scope of the project. For the specific project contents, please refer to the Bill of Quantities (see Volume II of the bidding document) and construction drawings.</p> <p>In addition, the bidder shall consider the maintenance Works of the roads on its own, and the road shall be restored to its original state after the project is completed, and the Tenderee shall not bear any additional fees.</p>
<p>Construction Period</p>	<p>18 Months (Check and Acceptance of Environmental Protection of Completed Projects should be met)</p>
<p>Defect Liability Period</p>	<p>The Defect Liability Period shall be seven hundred and thirty (730) days from the date of Completion of the Facilities (or any part thereof) or two years from the date of Operational Acceptance of the Facilities (or any part thereof), whichever first occurs.</p>

3. Bidding will be conducted through the Open Competitive Bidding procedures. The bidding is open to all eligible bidders in accordance with Chinese relevant bidding laws, regulations and the Procurement Policy of New Development Bank.

5. The attention of prospective Bidders is drawn to the eligibility and conflict of interest provisions under ITB 4.3 of the Bidding Documents. All Bidders found to have a conflict of interest shall be disqualified.
6. Bidders shall meet the following qualification requirements; detailed information is provided in the Bidding Documents:

Establishment Period	The bidder shall be an independent legal entity and must provide a copy of valid business license which shows it has been established for no less than five (5) years.
Business Capacity	Bidders' average annual turnover for each of the last three (3) years (2019-2021) shall not be less than RMB 50 million.
Contract Performance	<p>(1) From January 1, 2018 to the deadline for bidding, as a general contractor or subcontractor, at least have been completed in the supply and delivery of main equipment for a water plant or sewage plant with a scale of not less than 10,000 tons per day. For installation contracts, each contract value shall not be less than RMB 10 million.</p> <p>(2) From January 1, 2018 to the deadline for bidding, as a general contractor or subcontractor, at least have been completed in a civil construction contract for a water plant or sewage plant with a scale of not less than 10,000 tons/day, The value of each contract shall not be less than RMB 20 million.</p> <p>(3) From January 1, 2018 to the deadline for bidding, as a general contractor or subcontractor, at least 1 pipeline with a pipe diameter of DN500 and above and a length of 10 kilometers and above (steel pipe or Ductile ink tube) construction engineering contract, each contract value is not less than 10 million yuan.</p> <p>(4) The above conditions must be satisfied at the same time, and these contracts should have been successfully completed, subject to the completion time.</p> <p>Note: Corresponding documentary evidence (including but not limited to the bid winning notice, key pages of the contract, acceptance certificates, and copies of user certification) should be furnished in the bidding documents. Enterprise Qualification	<p>(a) For bidders registered in China or the bidder in the form of joint venture with a domestic firm, it shall possess:</p> <p>① valid Grade I or above level of Qualification Certificate for General Contracting of Municipal Public Construction; and</p> <p>② valid Grade II or above level of Qualification Certificate for General Contracting of Mechanical and Electrical Installation Engineering or valid Grade II or above level of Qualification Certificate for Professional Contracting of Construction Mechanical and Electrical Installation Engineering;</p> <p>③ valid Work Safety Certificate.</p> <p>(b) For bidders registered in other member countries (except China) shall provide the qualification certificate of the same level issued by the government agency at the same level, and also provide the registration certificate of the qualification certificate. At the same time, the bidder shall provide an undertaking to promise that the qualification certificate of the same level held by it is of the same level as the qualification certificate issued by the Chinese government, and is willing to provide the certificate for verification at any time. If the bidder is found to have made false statements or false undertakings, the Employer may take corresponding punitive measures, including but not limited to canceling the contract award, deducting the bid bond, prohibiting it from participating in other project bidding in the future or other circumstances that the Employer deems applicable.</p> <p>Copy of certificates shall be furnished in bids.</p>
Personnel	The Project Manager shall possess qualification of registered Constructor - Grade I specializing in municipal public construction (for joint venture, the qualification certificate holder must be the employee of the lead party of the joint venture). Copy of certificate shall be provided. For other personnel requirements, please refer to the bidding documents.
Financial Situation	Soundness of the Bidder's financial position showing long-term profitability demonstrated through audited annual financial

	statements (balance sheet, income statement and cashflow statement) for the last three years (2019-2021). As a minimum, a Bidder's net worth calculated as the difference between total assets and total liabilities for each of the three years (2019-2021) should be positive.
Cash Flow Capacity	Availability of or access to liquid assets <sup>1</sup> , line of credit, and other finances sufficient to meet any possible cash flow requirement which may arise during the execution of the contract shall not be less than: RMB 20 million.
Other Requirements	(a) From bid submission till contract award: ① the bidder shall not be listed in <a href="http://www.creditchina.gov.cn">www.creditchina.gov.cn</a> as "Discredit Entity Subject to Enforcement for Default" and shall not be listed in "National Enterprise Credit Information Publicity System" as "Discredit Enterprises with Serious Law Violation Practice"; ② the bidder shall not be declared as ineligible by membership country of New Development Bank. (b) Joint Venture is accepted for this contract. The maximum number of partners of Joint Venture shall be not more than two (the leading party should be a Municipal Public Construction company).

7. Bids must be delivered to the address below at or before 09:00 a.m. **August 9, 2022**. Late bids will be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend in person at the address below at 09:00 a.m. August 9, 2022. All bids must be accompanied by a bid security of CNY 500,000 as specified in the bids.
