Invitation for bid of Package No.W-04 & W-05 Under Reconstruction Engineering of Road G328 (Dingcheng to Yongkang)

1. General

The Government of the People's Republic of China has received the loan from the New Development Bank (hereinafter refer as "NDB"), toward the cost of Loan No.: 21CN03 Anhui Highway Development Project and it intends to apply part of the proceeds of this loan to payments under the Contract for Reconstruction Engineering of Road G328 (Dingcheng to Yongkang).

China International Tendering Co., Ltd. (hereinafter refer as Tendering Agency--"TA") authorized by and on behalf of Dingyuan County Transportation Bureau (hereinafter refer as "Employer") invites electronic bids from all eligible and qualified bidders for the construction and completion of above mentioned Engineering, Detail as below:

2. Description of Works

The construction site of this project is located in Chuzhou City, Anhui Province. The purchase scope covers all the items listed in the construction drawings and the bill of quantities. The description or work, estimated construction period, the Engineering's Estimated Value and contents of each Package are as follows :

3. Qualification Requirements

3.1 The qualifications and experiences of the Bidder shall meet the requirements of personnel, equipment, financial status & etc. that suitable for Contract performance. Foreign Bidder shall provide relevant certification issued by his government that equivalent to China's domestic certificates. detail as follows:

- All Bidders under each package shall have independent legal peraonality, and holding 1)Certification of "Highway engineering construction general contracting" Grade I or above issued by the Ministry of Housing and Urban-Rural Development, and 2)Work safety License (within validity period).
- 2. Experience:

Within last 5 years (from January 1st, 2017 to date of bid submission, subject to the issuing date of Final Acceptance) shall have completed at least: One contract of new-built or rebuilt highway Grade I with a length of no less than 10 km;The total Contract Value should not be less than CNY300 million.The construction of each of Above mentioned Contract should include roadbed or pavement works.

3. Project Manager:

1)The project manager proposed shall have Certificate of "National certified Constructor Professional level One of Road Engineering" and "Examination Certificate B of Work Safety" issued by provincial or above transportation department.

2) Within last 5 years (from January 1st, 2017 to date of bid submission, subject to the issuing date of Final Acceptance) shall have conducted as project manager at least: One contract of new-built or rebuilt highway Grade I with a length of no less than 10 km;The total Contract Value should not less than CNY300 million.The construction of each of Above mentioned Contract should include roadbed or pavement works.

3) The proposed project manager shall not serve as the project manager of other projects on date of bid submission.

The proof documents for each of the Contract submitted under the request of experience as mentioned in above Clause 2, and 3 shall include: 1) scanned copies of <Letter of Contract Award>, <Contract Documentation>, <Final Acceptance>; and 2) Screenshots of "Experience Information" downloaded from National Highway Construction Market Credit Information Management System (http://glxy.mot.gov.cn). Web screenshots shall specify the online search path for obtaining the screenshots. If all of the above-mentioned documents cannot prove the conformity of experience in detail, the bidder shall also provide documents describing the characteristics of the works, including the Bill of Quantities under the contract. The completion date of each Contract shall be subjected to the issuing date of Final Acceptance.

- 4. Eligibility —None of the following bidders will be accepted.
 - 1) Listed in the Chinese Court as executors of dishonesty.

2) The bidder or its legal representative or the proposed project manager (project leader) who listed in Criminal bribery of by the People's Procuratorate.

3) Listed in the abnormal enterprise operation catalogue by the Industrial and commercial administrative departments (Market supervision and administration department).

4) Listed in major tax violation cases by tax authorities.

5) Blacklist of wage arrears for migrant workers by Ministry of Human Resources and Social Security.

6) Not debarred by any government agencies from NDB member countries. Please indicate it in the "Commitment Letter of Bad Records" in Appendix I, Section 9.7) Restricted for bidding due to the cases of violation of Chinese law.

5.Other requirements :The bidder shall have corresponding abilities in general personnel and equipment. Please refer to the bidding documents for specific requirements.

6.Bidders are requested to log in the list of qualified enterprises for highway construction in the National Highway Construction Market Credit Information Management System (http://glxy.mot.gov.cn) and confirm that the information in the list is completely accurate.

3.2 Joint Venture, Consortium or Association were not acceptable.

3.3 The bidder could select one or total 2 packages to bid for. However, each bidder could be awarded the Contract only under one package.

3.4 Bidders must strictly avoid conflicts with other assignments or their own interests, and act without consideration for future work. Bidders found to have a conflict of interest shall be disqualified. Different units with the same person in charge or holding or managing relationship shall not participate in the same bidding section; otherwise, the bids shall be deemed invalid.

3.5 The bidder in China executive information network (http://zxgk.court.gov.cn/ shixin/) was faithless person subjected to execution list, is not accepted.
