## INTERNATIONAL PUBLIC BIDDING NOTICE No. CPI/02/2022 - IPPUC

The INSTITUTE OF RESEARCH AND URBAN PLANNING OF CURITIBA - IPPUC, makes public, for the knowledge of the interested parties, that it will carry out a Technical and Price Bidding, aiming at the selection and contracting of consulting companies from NDB member countries to provide of the services described below, in accordance with the specifications that form an integral part of the Public Notice in question.

The purpose of this bidding is the hiring of consulting company(ies) to PROVIDE TECHNICAL SUPPORT SERVICES FOR THE SUPERVISION OF URBAN INFRASTRUCTURE WORKS OF THE CURITIBA SUSTAINABLE URBAN MOBILITY PROGRAM PARTIALLY FINANCED BY NEW DEVELOPMENT BANK - NDB.

The estimated value of the Service with BDI totals BRL 20,495,907.26 (twenty million, four hundred and ninety-five thousand, nine hundred and seven reais and twenty-six cents). This bidding will be carried out in national currency (Reais – R\$) and payments will be made exclusively in Brazil.

The location and scope of the work of the technical teams to support the supervision of works comprise the following road sections, per team:
