Late bids will be rejected. Bids will be opened in the presence of Bidders' representatives who choose to attend at the address below at 14:00 Moscow time October 12, 2022.

6. Bids must be delivered to the address below on or before 14:00 Moscow time November 15, 2022. Bids need to be secured by a bid security. The amount of Bid Security required is RUB 25,000,000.00 (twenty five million) for Lot 1 and RUB 25,000,000.00 (twenty five million) for Lot 2, or an equivalent amount in the currency of Bid, or an equivalent amount in a freely convertible currency. Late bids will be rejected. Bids will be opened in the presence of Bidders' representatives who choose to attend at the address below at 14:00 Moscow time November 15, 2022.
