INVITATION FOR PREQUALIFICATION APPLICATION

- A) The Government of Assam through Government of India has proposed/applied for a Loan from New Development Bank towards the cost of the 'Construction of 4 lane Extradosed PSC Bridge over the River Brahmaputra connecting Palasbari and Sualkuchi including via duct, approaches, river training works etc on EPC mode.' (herein after called" the Project"). It is intended that part of the proceeds of this Loan will be applied to eligible payments under the contract resulting from the bidding for which this prequalification is conducted.
- B) Prequalification will be conducted through New Development Bank Procurement Policy/State Procurement Rules, and is open to all Applicants from eligible NDB members countries available at the website "http://www.ndb.int>about-us>organization.members" only.
- C) The Chief Engineer (EAP), PWRD, Assam now invites online Pre-Qualification Application from eligible Applicants for the Project.
- D) A complete set of the Prequalification Documents may be viewed/downloaded from the official Portal https://www.assamtenders.gov.in. From 21/03/2023 to 05/05/2023. The intending bidder shall have to make online payment through E- Tender portal for a sum of
- E) Rs.50,000/- (Rupees Fifty thousand) only towards the cost of PQ document processing fees (non-refundable) (including all taxes) on the date of submission of PQ Application. Applicants will be required to register on the website. The Applicants will be responsible for ensuring that any addendum available on the website is also downloaded and incorporated.
- F) For submission of Application, Applicant is required to have Digital Signature Certificate (DSC) from one of the Certifying Authorities authorised by Government of India for issuing DSC. Aspiring Applicants who have not obtained the user ID and password for participating in e-procurement in the Project may obtain the same from the website:https://www.assamtenders.gov.in.
- G) Completed application for pre-qualification should be submitted online through E-Tender Portal https://www.assamtenders.gov.inon or before 1400 Hrs on May 5, 2023.

- H) PQ Application submission through any other mode shall not be entertained. However, receipt of online submission of PQ documents processing fee, Power of Attorney and other documents etc shall be submitted by the Applicant on or before 1400 Hrs on May 5, 2023.
