PUBLIC BIDDING NOTICE No. CP 07/2022 - IPPUC-NDB

The INSTITUTE OF RESEARCH AND URBAN PLANNING OF CURITIBA - IPPUC makes public, for the knowledge of interested parties, that it will carry out Public Bidding, of the Lowest Price per lot type, in the indirect execution modality, under the contract for price regime, aiming at the selection and contracting of company(ies) for the provision of the services described below, in accordance with the specifications that are an integral part of this Notice and its annexes.

The object of this bidding is the selection and Hiring of a specialized company to

Lot - 01 Hiring of a specialized company to provide services for the elaboration of executive engineering and architecture projects, with the objective of building the new Cic-Norte terminal and adapting the surrounding road system - and

Lot – 02 Hiring of a specialized company to provide services for the elaboration of executive engineering and architecture projects, with the objective of building the new building of the Campo Comprido terminal and adapting the surrounding roads.

According to the specifications contained in Annex B - Term of Reference, in the Public Notice and other annexes. The maximum estimated total value of the bidding is BRL 866,722.52 (eight hundred and sixty-six thousand, seven hundred and twenty-two reais and fifty-two cents) for Lot 01 and

The maximum estimated total value of the bidding is BRL 873,171.64 (Eight hundred and seventy-three thousand, one hundred and seventy-one reais and sixty-four cents) for Lot 02.

Totaling the amount of BRL 1,739,894.16 (One million, seven hundred and thirty-nine thousand, eight hundred and ninety-four reais and sixteen cents). This work is part of the Curitiba Sustainable Urban Mobility Program – BRT Capacity and Speed Increase Project in the extension of the East West and South BRT Axis, financed by the New Development Bank – NDB.
