- 1.0 The MMRDA has received financing from the New Development Bank (NDB) towards the cost of "DESIGN, MANUFACTURE, SUPPLY, INSTALLATION, TESTING AND COMMISSIONING OF 2 NOS. 110 KV RECEIVING SUBSTATION INCLUDING 110 KV, 33kV & 25kV CABLING WORK, COMPLETE 25kV OVERHEAD CATENARY SYSTEM ALONGWITH SWITCHING STATION, 33kV AUXILIARY POWER DISTRIBUTION SYSTEM INCLUDING 33/0.415 kV AUXILIARY SUB-STATION (ASS) AND COMPLETE SCADA SYSTEM FOR MAIN LINE & DEPOT OF MUMBAI METRO LINE 2B OF MMRDA", and it intends to apply part of the proceeds of this financing to payments under the contract named above. Bidding is open to Bidders from eligible source countries of NDB.

- **3.0** Open competitive bidding will be conducted in accordance with Single Stage two Envelope procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
- **4.0** Only eligible Bidders with the following key qualifications defined in the Bidding Document may participate in this bidding:

4.1 Minimum Eligibility Criteria:

4.1.1 Work Experience:

• General Experience:

Experience under the Construction Contracts in the role of prime contractor, Lead partner of JV or Consortium for at least last **5 years**.

• Specific Construction and Contract Management (Financial):

Tenderer should have Experience of satisfactory completion of Traction Power Supply/ OHE work for Metro Rail/ Suburban Rail/ Mainline Railway / Railway Electrification works as a prime contractor (Single Entity or JV Member(x)) during last 05 years up to last day of month previous to the one in which bids are invited.

One contract of Traction Power Supply/OHE work for Metro Rail/ Suburban Rail/ Mainline Railway / Railway Electrification of **INR 397.26 Crores** or more.

OR

Two contracts of Traction Power Supply/ OHE work for Metro Rail/ Suburban Rail/ Mainline Railway / Railway Electrification of **INR 248.28 Crores each** or more.

OR

Three Contracts of Traction Power Supply/ OHE work for Metro Rail/ Suburban Rail/ Mainline Railway / Railway Electrification of **INR 198.63Crores** each or more.

• Specific Construction and Contract Management (Technical)

For above or other contracts (Cumulative/ Total) should have successfully completed as prime contractor (Single entity or JV member^(xi)), during last 5 years, a minimum **experience in all the following key activities**:

- 1. 25kV or above FOCS work(for Metro Rail/ Suburban Rail/ Mainline Railway/ Railway Electrification of minimum 75 TKM including design, erection, testing and commissioning including at least 1 set of SSP
- 2. 11 kV and above GIS substation and associated cable network with at least 5 substations (for Metro Rail/ Suburban Rail/ Mainline Railway/ Power Project) including design, erection, testing and commissioning.
- 3. 66 kV and above GIS substation (for Metro Rail/ Suburban Rail/ Mainline Railway/ Power Project) including design, erection, testing and commissioning.

- 4. SCADA for Traction or Power Supply System (for Metro Rail System/ Suburban/ main line Railway Project / Power Project) including design, erection, testing and commissioning.
- **4.1.2 Financial Standing:** In addition to the Criteria mentioned in the Tender Documents, the following financial standings will also be considered.
- i. **T1 –Liquidity:** The Bidder must demonstrate that its financial resources less its financial obligations for its current contract commitments meet or exceed the total requirement for the Subject Contract of **INR 20.69Crore.**
- **ii. T2 Net Worth:**As a minimum, the Bidder's net worth should be positive for atleast 03 years out of last 05 financial years calculated as the difference between total assets and total liabilities.
- iii. Average Annual Turnover: Minimum average annual turnover of INR 124.14Crore calculated as total certified payments (certified by CA) received for contracts in progress or completed, within the last 05 years.
- iv. Bid Capacity Criteria: The tenderers will be qualified only if their available bid capacity is more than the approximate cost of work as per EQC.

 - a. e-Envelope "A" (Tender Fee, EMD & PoA):

Bidder should generate and upload the following:

- i. Receipt for e-tender fee.
- ii. Receipt of Challan of online payment of Tender Security (EMD),
- iii. Copy of Bank Guarantee towards balance Tender Security (EMD)
- iv. Specific Power of Attorney supported with Board resolution.

b. e-Envelope "B" (Technical bid):

Bidder shall upload scanned copies of Technical Documents.

c. e-Envelope "C" (Financial bid):

Bidder shall quote his offer based on his filled Price Schedules and scanned Demand Draft/ Bank Guarantee towards Additional security deposit, if offer is below the cost put to Tender in accordance with the Additional Clause 71 in SCC.

Bids will be opened promptly after the deadline for bid submission in the presence of Bidders' representatives who choose to attend.

10.0 Single-Stage Two- Envelope:

Bidder should note that there are two envelopes. One for Technical Bid / Package and other for Financial Bid / Package.

Further, e-tendering system of MMRDA has two sub-envelopes in Technical Bid / Package. The first sub-envelop is Envelope "A" which consists of Tender Security (EMD and Bank Guarantee), Cost of Tender fee and specific power of attorney supported with board resolution. The second sub-envelop is Envelope "B" which consists of all Technical Documents.

Financial Bid / Package has only one envelop i.e., Envelope "C". Bidder has to submit their financial bid and the Demand Draft/ Bank Guarantee of Additional Security deposit (ASD)in Envelope "C".

Bidder shall quote his offer based on his filled Bill of Quantities (Section - 4).
