Each bidder:

1) Now that the Purchaser needs to answer the questions raised by some bidders and changes the bidding documents, and the deadline for bidding is less than 15 days at this time, according to the requirements of relevant laws and regulations, the deadline for bidding is now extended to 9:30 am on June 17, 2021, the deadline for the purchase of bidding documents has been extended to June 16, 2021.

2) Article 14.1 of Chapter VI, attachment 1, Item No.10 Automatic Isostatic Pressing Line R400, the Minimum Standard/Requirement will be amended as follows:

- 1) If the bidder acts as an agent, the manufacturer shall issue a letter of authorization.
- 2) The manufacturer must have the legal qualification to produce the equipment meeting the requirements of the technical specifications of the bidding, provide the business license, and have been engaged in the manufacturing of the equipment provided for at least five years;
- 3) In recent 5 years (2016-2020), the manufacturer must have the supply experience of more than 1 set of similar equipment (Isostatic pressing molding equipment), and must provide a copy of the contract, together with the contact person and telephone number of the user, for the verification of the Purchaser.
- 4) The manufacturer has stable technical support and after-sales service ability in Jiangxi Province. It is required to provide details of after-sales service organization in Jiangxi Province and letter of commitment for after-sales service, and provide address, contact person and contact telephone number of after-sales service organization for verification by the Purchaser.
- 5) The manufacturer shall provide the original commitment letter of technical parameters issued by the manufacturer for the project.
