S247 (Weiwu Road) Reconstruction Project (Phase II)

1. General

The Government of the People's Republic of China has received the loan from the New Development Bank (hereinafter refer as "NDB"), toward the cost of Loan No. 21CN03 for Anhui Highway Development Project and it intends to apply part of the proceeds of this loan to payments under the Contract No. W13 for S247 (Weiwu Road) Reconstruction Project (Phase II).

China International Tendering Co., Ltd. (hereinafter refer as Tendering Agency) authorized by and on behalf of Dangtu County Transportation Bureau (hereinafter refer as "Employer") invites electronic bids from all eligible and qualified bidders for the construction and completion of above mentioned Engineering, Detail as below:

2. Description of the works

S247 (Weiwu Road) Reconstruction Project (Phase II) is located in Dangtu County, Ma'anshan City, starting from the Guxi River in Dangtu County, going south through Moat Town, Shigiao Town, Huangchi Town, and finally Wuhuang Road in Huangchi Town, with a total length of 23.23 kilometers (K29+000~K52+225). The project adopts first-class highway technical standards, two-way four lanes, design speed of 80 km / h, roadbed width of 24.5 meters, pavement width of 21 meters, asphalt concrete pavement (pavement structure adopts 18cm low-dose cement stabilized gravel + 36cm cement stabilized crushed stone + 8cmAC-25C coarse-grained asphalt concrete + 6cmAC-20C medium-grained modified asphalt concrete + 4cmAC-13C (basalt) fine-grained modified asphalt concrete pavement). The main construction contents include roadbed, bridge and culvert, pavement, traffic engineering and mechanical and electrical facilities, greening and supporting works. The main engineering quantities include 1,626,900m³ of roadbed earthwork, 5 bridges and 7 middle bridges, 1310818m of crushed stone piles treated by soft foundation, 241056m of PHC prestressed pipe piles, 308486m³ of cement-stabilized crushed stone base layer, and 89849m³ of asphalt concrete pavement. The planned duration is 730 days. The tender control price of this project is CNY973,766,600.00.

There is a total of one package under this bid, and the scope of supply covers all the contents listed in the construction drawings and the bill of quantities

3. Qualification Requirements

3.1 The qualifications and experiences of the Bidder shall meet the requirements of personnel, equipment, financial status & etc. that suitable for Contract performance. Foreign Bidder shall provide relevant certification issued by his government that equivalent to China's domestic certificates. detail as follows:

1. All Bidders shall have independent legal personality, and holding 1) Certification of "Highway engineering construction general contracting" Grade I or above issued by the Ministry of Housing and Urban-Rural Development, and 2) Work safety License (within validity period).

2. Experience:

Since January 1st, 2018, the bidder has independently completed at least one general contracting of new (or reconstructed) first-class highway projects with a mileage of not less than 15 kilometers as a general contractor. The main quantities include roadbed, pavement and bridge works.

- 3. Project Manager:
- 1) The project manager proposed shall have Certificate of "National certified Constructor Professional level One of Road Engineering"; and
- 2) "Examination Certificate B of Work Safety" issued by provincial or above transportation department within validity period. The industry category code for the certificate number is G (Highway Engineering); and
- Have a senior or above professional title in highway engineering related majors; and
- 4) Since January 1st, 2018, he has served as the project manager of at least one new (or reconstructed) highway project of not less than 15 kilometers and above of the first class, and the project has been handed over for acceptance, the main works include roadbed engineering, pavement engineering and bridge engineering; and
- 5) The proposed project manager shall not serve as the project manager of other projects on date of bid submission; or he is able to withdraw from other projects and act as project manager for this project within 30 working days after the issuance of Notice of Acceptance for this project.
- 4. Technical Director:
- 1) Have a senior or above professional title in highway engineering related majors; and
- 2) "Examination Certificate B of Work Safety" issued by provincial or above transportation department within validity period. The industry category code for the certificate number is G (Highway Engineering); and
- 3) Since January 1st, 2018, he has served as the technical director of at least one new (or reconstructed) highway project of not less than 15 kilometers and above of the first class, and the project has been handed over for acceptance, the main works include roadbed engineering, pavement engineering and bridge engineering; and
- 4) The proposed technical director shall not serve as the project manager of other projects on date of bid submission; or he is able to withdraw from other projects and act as technical director for this project within 30 working days after the issuance of Notice of Acceptance for this project.

The time for completion of all the performance described in paragraphs 2, 3 and 4 above shall be subject to the completion date inquired by the Ministry of Transport's National Highway Construction Market Credit Information Management System (https://glxy.mot.gov.cn/) or the provincial transportation department's Highway Construction Market Credit Information Management System. "Major Quantities" means publicly available information available from the above websites.

5. The average annual turnover of bidders in the recent three years (year2019, 2020 and 2021) is not less than 2 billion yuan. A Letter of Reference issued by the commercial bank (state-owned or joint-stock bank at sub-branch level or above), indicating that a special line of credit or banking facility were obtained by

the bidder for the execution of this Contract which not less than CNY 120 million shall be provided by the bidder.

- 6. Eligibility None of the following bidders will be accepted.
- 1) Listed in the Chinese Court as executors of dishonesty.
- 2) The bidder or its legal representative or the proposed project manager (project leader) who listed in Criminal bribery of by the People's Procuratorate.
- 3) Listed in the abnormal enterprise operation catalogue by the Industrial and commercial administrative departments (Market supervision and administration department).
- 4) Listed in major tax violation cases by tax authorities.
- 5) Blacklist of wage arrears for migrant workers by Provincial or above department of Human Resources and Social Security.
- 6) Debarred by any government agencies from NDB member countries. Please indicate it in the "Commitment Letter of Bad Records" in Appendix I, Section 9.
- 7) It is prompted as a "risk trading object" by the "Hefei Public Resources Trading Center Electronic Service System".
- 8) Restricted for bidding due to the cases of violation of Chinese law.
- 7. Other requirements: The bidder shall have corresponding abilities in general personnel and equipment. Please refer to the bidding documents for specific requirements.
- 8. Bidders are requested to log in the list of qualified enterprises for highway construction in the National Highway Construction Market Credit Information Management System (http://glxy.mot.gov.cn) and confirm that the information in the list is completely accurate.
- 3.2 Joint Venture, Consortium or Association were not acceptable.

3.3 Bidders must strictly avoid conflicts with other assignments or their own interests, and act without consideration for future work. Bidders found to have a conflict of interest shall be disqualified. Different units with the same person in charge or holding or managing relationship shall not participate in the same bidding section; otherwise, the bids shall be deemed invalid.

3.4 The bidder in the "China Executive Information Disclosure Network" (http://zxgk.court.gov.cn/ shixin/) was faithless person subjected to execution list, is not accepted.
