S334 Eshan Road Extends East (Yanjiang Highway to Wuxuan Highway) New Build Engineering Phase II [K5+800-K10+860]

1. General

The Government of the People's Republic of China has received the loan from the New Development Bank (hereinafter refer as "NDB"), toward the cost of Loan No. 21CN03 for Anhui Highway Development Project and it intends to apply part of the proceeds of this loan to payments under the Contract No. W-01 for S334 Eshan Road Extends East (Yanjiang Highway to Wuxuan Highway) New Build Engineering Phase II [K5+800-K10+860].

China International Tendering Co., Ltd. (hereinafter refer as Tendering Agency) authorized by and on behalf of Wuhu Highway Management Service Center (hereinafter refer as "Employer") invites electronic bids from all eligible and qualified bidders for the construction and completion of above mentioned Engineering, Detail as below:

2. Description of the works

The western end of the S334 project starts from the new construction project (phase I) of the eastern extension of S334 Eshan Road (Yanjiang Expressway to Wuxuan Expressway), crosses the current Jingshi Road (planned Mengxi Road), crosses Qingyi River and Wutun Road in the east, and ends at the Yingang Interchange of Wuxuan Expressway.

The construction site of this project is in Wuhu City, Anhui Province, and the bidding scope covers all the contents listed in the construction drawing documents and the bill of quantities. The project overview, planned duration, estimated contract value and etc. are as follows:

W-01	The total length of the road is 5.06 kilometers (K5+800-K10+860), the main line of Eshan Road is a first-class highway (with the function of an urban expressway), the roadbed is 53m wide, the design speed is 80km/h, and the auxiliary road is a third-level highway (refer to the urban secondary trunk road standard), and the roadbed is 31.5 meters wide. auxiliary roads are made of asphalt concrete pavement. The main construction content includes roadbed, pavement, bridge and culvert (including special bridge), transportation facilities and supporting projects.

3. Qualification Requirements

3.1 The qualifications and experiences of the Bidder shall meet the requirements of personnel, equipment, financial status & etc. that suitable for Contract performance. Foreign Bidder shall provide relevant certification issued by his government that equivalent to China's domestic certificates. detail as follows:

1. Qualification:

All Bidders shall have independent legal personality, and holding 1) Certification of "Highway engineering construction general contracting" Grade I or above issued by the Ministry of Housing and Urban-Rural Development; 2) Work safety License (within validity period); and 3) Certificate of "Bridge engineering professional contracting first-class qualification".

2. Experience:

The bidder shall had at least: a) 1 general contracting of new or reconstructed first-class highway Contract with an amount of not less than 300 million yuan, including the performance of roadbed, pavement and extra large bridge works (hereinafter refer as "Achievement A"); or b) 1 general contracting of new or reconstructed first-class highway Contract with an amount of not less than 300 million yuan, including the performance of roadbed, pavement, and plus another 1 Contract that including the performance of new or reconstructed of extra large bridge works (hereinafter refer as "Achievements B"), the Contracts submitted under both "Achievement A" and "Achievements B" shall be completed within the last five years (subject to the issuing date of Final Acceptance Certificate and counting from the deadline of bid submission).

- 3. Project Manager:
- 1) The project manager proposed shall have Certificate of "National certified Constructor Professional level One of Road Engineering"; and
- 2) "Examination Certificate B of Work Safety" issued by provincial or above transportation department within validity period; and
- 3) As a project manager, in the last five years (subject to the issuing date of Final Acceptance Certificate and counting from the deadline of bid submission), shall had at least 1 "Performance A" or 1 group of "Performances B"; and
- 4) The proposed project manager shall not serve as the project manager of other projects on date of bid submission; or he is able to withdraw from other projects and act as project manager for this project within 15 working days after the issuance of Notice of Acceptance for this project.

The proof documents for each of the Contract submitted under the request of

experience as mentioned in above Clause 2, and 3 shall include: 1) scanned copies of <Letter of Contract Award>, <Contract Documentation>, <Final Acceptance>; and 2) Screenshots of "Experience Information" downloaded from National Highway Construction Market Credit Information Management System (http://glxy.mot.gov.cn). Web screenshots shall specify the online search path for obtaining the screenshots. If all of the above-mentioned documents cannot prove the conformity of experience in detail, the bidder shall also provide documents describing the characteristics of the works, including the Bill of Quantities under the contract. The completion date of each Contract shall be subjected to the issuing date of Final Acceptance.

- 4. The average annual turnover of bidders in the recent three years (year2020, 2021 and 2022) is not less than 1.083 billion yuan. A Letter of Reference issued by the commercial bank (state-owned or joint-stock bank at sub-branch level or above), indicating that a special line of credit or banking facility were obtained by the bidder for the execution of this Contract which not less than 108.3 million yuan shall be provided by the bidder.
- 5. Eligibility —None of the following bidders will be accepted.
- 1) Disqualified from bidding in Anhui Province or prohibited from entering the highway construction market in Anhui Province by the transportation authorities at the provincial level or above, and within the penalty period.
- 2) In a state of being ordered to suspend business, financial receivership, freezing, bankruptcy.
- 3) The bidder and/or its legal representative, the recommended project manager, and the technical director have committed the crime of bribery.
- 4) The bidder in the "China Executive Information Disclosure Network" (http://zxgk.court.gov.cn/ shixin/) was faithless person subjected to execution list
- 5) Blacklisted by international financial organizations and within the penalty period.
- 6) Debarred by any government agencies from NDB member countries. Please indicate it in the "Commitment Letter of Bad Records" in Appendix I, Section 9.
- 7) It is prompted as a "risk trading object" by the "Hefei Public Resources Trading Center Electronic Service System".
- 8) There are other circumstances that restrict their bidding as stipulated by Chinese laws and regulations.
- Other requirements: The bidder shall have corresponding abilities in general personnel and equipment. Please refer to the bidding documents for specific requirements.
- 7. Bidders are requested to log in the list of qualified enterprises for highway construction in the National Highway Construction Market Credit Information Management System (http://glxy.mot.gov.cn) and confirm that the information in the list is completely accurate.
- 3.2 Joint Venture, Consortium or Association were not acceptable.

- 3.3 Bidders must strictly avoid conflicts with other assignments or their own interests, and act without consideration for future work. Bidders found to have a conflict of interest shall be disqualified. Different units with the same person in charge or holding or managing relationship shall not participate in the same bidding section; otherwise, the bids shall be deemed invalid.
- 3.4 The bidder in the "China Executive Information Disclosure Network" (http://zxgk.court.gov.cn/ shixin/) was faithless person subjected to execution list, is not accepted.
