

## **Invitation for Bid (IFB)**

1 Yinchuan Municipal Transport Bureau has applied for a loan from the New Development Bank (herein after referred to “NDB”) to pay for Ningxia Yinchuan Integrated Green Transport Development Project, and plans to use a part of this loan to cover the eligible expenditure under the contract for the procurement and installation for Security Monitoring and Intelligent System of Transportation Yards.

2 Yinchuan Municipal Transport Bureau hereby invites eligible bidders to submit sealed bids for the following goods and relevant services:

This project relies on advanced technologies such as "video+AI+algorithm" to build an intelligent system for transportation yards. The 25 transportation yards involved in this project include 3 new stations: the initial and terminal bus station in Lufang Town, Yongning, the bus parking lot in the Convention and Exhibition Center, the parking lot in Yinchuan Economic Development Zone, 2 expansion stations: Xixia Square parking lot, Yuehai Wanjia initial and terminal bus station, 20 existing stations: the initial and terminal bus station in Jing'an Jiayuan, the bus parking lot in Railway Station, the bus parking lot at the north gate Tongda North Street Bus Yard, Yuehai Bay Central Business District Bus Hub, You'ai Central Road Initial and Terminal Station, Baohu Parking Lot, Fertilizer Plant Parking Lot, Ningjiao Base Initial and Terminal Station, Petroleum City Parking Lot, Jinfeng Science and Technology Park Initial and Terminal Station, Binhe New Area Bus Integrated Hub Station, Beita East Road Initial and Terminal Station, Yongning City Central Parking Lot, Gaoqiao Resettlement Area Bus Initial and Terminal Station, Mancheng South Street Initial and Terminal Station, Art School Parking Lot, Xixia Park Parking Lot, Wenchang South Road Bus Parking Lot, Bayi Parking Lot, etc and construction of intelligent management platforms and central machine rooms.

The transportation yard level system under construction consists of station intelligent management platform, charging pile monitoring, video monitoring, parking lot management, intrusion alarm, integrated wiring, patrol system, power supply and grounding subsystems. The station intelligent management platform shall meet the data access of other newly added station security monitoring equipment and intelligent systems. The station intelligent management system data shall be connected to the central level of the command center for unified management.

The delivery time for the above goods and related services is two hundred and seventy (270) days after the signing of the contract.

3 Bidding will be conducted through Open Competitive Bidding procedures, and all eligible bidders conforming with the procurement guidelines of the New Development Bank can participate in the bidding.

5 The attention of prospective Bidders is drawn to the eligibility and conflict of interest provisions under Article 4 of the Instructions to Bidders in these bidding documents. All Bidders found to have a conflict of interest shall be disqualified.

6 Qualification requirements of the bidder include following:

1)The bidder shall come from member countries of the New Development Bank with independent legal person status;

2)The bidder's amount of annual net assets shall be positive in recent 4 years (2018-2021), and average annual turnover shall no less than CNY 30 million or equivalent foreign currency;

3)The bidder shall have at least one completed similar experience of Security Monitoring and Intelligent System construction with an individual contract amount of no less than CNY 30 million or equivalent foreign currency in recent 5 years (2018-deadline for bid submission) ;

4)The bidder shall have and no practice of fraudulently winning the bid or failure to fulfill the obligations under the contract after winning the bid within recent 5 years (from 2018 to the Deadline for Submission of Bids);

5)The bidder shall not be restricted from bidding by the governments of the member countries of the New Development Bank;

6)The bidder from within P.R. China shall not be included in the list of persons subject to enforcement for dishonesty published by the "Credit China" website ([www.creditchina.gov.cn](http://www.creditchina.gov.cn));

7)Bid by Joint Venture is not accepted.

Details will be provided in the bidding documents.

7 Eligible bidders who are interested may log into the Ningxia Hui Autonomous Region Public Resources Trading Network (<http://www.nxggzyjy.org/>) to register the bidding during the period from the date of Mar 28,2023 to 18: 00, Apr 26, 2023 (Beijing time, excluding statutory public holidays and statutory holidays) and then download the electronic bidding documents freely as prompted.

Note: ① The transaction management platform system implements CA lock authentication and secure login management. ② Before bid opening, each bidder shall pay timely attention to the columns of "Change Announcement", "Clarification and Modification" and "View Reply" in the Ningxia Hui Autonomous Region public resources trading network, and timely check the adjustment of time or contents. The purchaser (procurement agency) will not notify in any other form. If the bidding is failed because of failure to pay attention to the tender announcement (clarification,

supplement etc.) or change announcement due to reasons attributable to the bidder itself, the consequences shall be borne by itself.

③Foreign bidder shall also register on Ningxia Hui Autonomous Region Public Resources Trading Network (<http://www.nxggzyjy.org/>), the Procurement Agency will provide necessary assistance for the registration procedures.

8 All bids shall be submitted or mailed to the address set out at this Invitation for Bid before 9:00a.m, Apr 27, 2023 (Beijing time), submission of bid by email is allowed and only for foreign bidder. Late bid will be rejected. If foreign bidder submits the bid by email, the electronic bid shall be encrypted and sent to [liwenduo@minmetals.com](mailto:liwenduo@minmetals.com) before the deadline for submission of bids. And the decryption password shall be sent to the above email within 15 minutes after the deadline for submission of bids. If the bidder fails to submit the bid document and decryption password according to the above requirements, its bid will be considered to be rejected. The bid will be opened in public at the address set out at this Invitation for Bid. The bidder may send representatives to participate in the bid opening. The bid opening time is 9:00a.m, Apr 27, 2023 (Beijing time). A bid security must be included in the bid. The amount of the bid security is RMB 500,000.00 (RMB Five Hundred Thousand only).
