TheMMRDA has received financing from the New Development Bank (NDB) towards the cost of "DESIGN, MANUFACTURE, SUPPLY, INSTALLATION, TESTING AND COMMISSIONING OF COMMUNICATION BASED SIGNALLING & TRAIN CONTROL, TELECOMMUNICATION & PLATFORM SCREEN DOORS SYSTEM FOR MAIN LINE & DEPOT OF LINE 6 [SWAMI SAMARTH NAGAR TO VIKHROLI (EEH)] OF MUMBAI METRO RAIL PROJECT OF MMRDA", and it intends to apply part of the proceeds of the financing to payments under the Contract named above. Bidding is open to Bidders from eligible source countries of NDB.

- 3.0 Open Competitive Bidding will be conducted in accordance with NDB's Single Stage Two Envelope procedure and is open to all Bidders from eligible countries as described in Bidding Document.
- 4.0 Only Eligible Bidders with the following key Qualifications defined in the Bidding Document may participate in this Bidding.

4.1 Minimum Eligibility Criteria:

4.1.1 Work Experience:

- **General Construction Experience:** Experience under the Construction Contracts in the role of prime contractor, JV Member or Management Contractor for at least the last 10 years ending last day of the month previous to the month of tender submission.
- Specific Construction and Contract Management:

(A) Work Experience Requirements for Train Control and Signalling Systems:

The applicant (or the concerned member of JV/Consortium) should have successfully carried out the following work(s) in the last 10 (TEN) years ending last day of the month previous to the month of tender submission.

(i) At least one similar* work of Design, Supply, Installation, Testing and commissioning of Signalling & Train Control system using radio based CBTC with moving block including CBI & ATP subsystem in Metro Rail of value not less than **INR 92.50 Cr.**

OR

At least two similar* works, each of Design, Supply, Installation, Testing and commissioning of Signalling & Train Control system using radio based CBTC with moving block including CBI & ATP subsystem in Metro Rail of value not less than **INR 57.82 Cr.**

OR

At least three similar* works, each of Design, Supply, Installation, Testing and commissioning of Signalling & Train Control system using radio based CBTC with moving block including CBI & ATP subsystem in Metro Rail of value not less than **INR 46.25 Cr.**

- (ii) At least two CATC works (out of which at least one CBTC) shall be outside the country of origin/country of manufacture or in India.
- (iii) In the above CBTC work(s) under Clause (A) (i), CBI & ATP subsystem shall be from OEMs under same parent company. Applicant must have experience of integration of all major subsystems (Interlocking, ATP, ATS and Radio) in a CBTC project.
- (iv) Applicant must have experience of integration of Signalling system with all subsystems (Civil, Rolling stock, Telecommunication, Track, Traction,

Platform screen door) in at least one CBTC work out of the work(s) submitted in support of work experience under Clause (A) (i).

(v) At least one 10 Route Km of UTO has been commissioned and proven for one year with satisfactory operation by any of the group company under same parent company.

AND

(B) Work Experience Requirements for Telecommunication Systems:

The applicant (or the concerned member of JV/Consortium) should have successfully carried out the following work(s) in the last 10 (TEN) years ending last day of the month previous to the month of tender submission.

(i) At least one similar** work of Design, Supply, Installation, Testing and commissioning of Telecommunication Systems of value of minimum INR 52.17 Cr

OR

At least two similar** works, each of Design, Supply, Installation, Testing and commissioning of Telecommunication Systems of value of minimum INR32.61 Cr

OR

At least three similar** works, each of Design, Supply, Installation, Testing and commissioning of Telecommunication Systems of value of minimum INR 26.08 Cr

(ii) If the bidder is a Foreign bidder or JV/Consortium and has a foreign partner and above work(s) have beendone by the Foreign Bidder / foreign partner of JV and such work(s) were done in the country of the Foreign Bidder / foreign partnerthen inaddition tothis,theforeign partner must have done at least one work of valueINR 26.08 Croutside the country of Origin

- (ii) Design, Supply, Installation, Testing and Commissioning of Platform Screen Door System (PSD) System at least 240 PSD /PED/PG Doors in metro environment shall be in satisfactory operation for at least 1 (one) year works for metro railway station or other infrastructure such as Monorail/ Highspeed Rail with complete Platform Screen Door System (PSD) System including PSD, EED, PED, FS, PSL, PSC
- (iii) If the bidder is a Foreign bidder or JV/Consortium and has a foreign partner and above work(s) have beendone by the Foreign Bidder / foreign partner of JV and such work(s) were done in the country of the Foreign Bidder / foreign partnerthen inaddition tothis,theforeign partner must have done at least one work of value INR 30.02 Cr outside the country of Origin

The similarity shall be based on the physical size, complexity, methods/technology and/or other characteristics described in Section 6- Scope of Works. Summation of number of small value contracts (less than the value specified under requirement) to meet the overall requirement will not be accepted.

*Similar Work(s) means design, manufacture, supply, installation, testing and commissioning of CBTC/UTOs for Metro Rails System which are Substantially complete and Client (or end user) has issued Certificate.

**Similar Work(s) means design, manufacture, supply, installation, testing and commissioning of Telecommunications for Railway Station(s) / Metro Station(s) / Airport(s) / Monorail / High Speed Rails System involving at least 4 systems out of FOTS, CCTV, PABX, TETRA, PIDS, MCS, ACIDS& PAS which are Substantially complete and Client (or end user) has issued Certificate.

***Similar Work(s) means design, manufacture supply, installation, testing, commissioning of Platform Screen Door (PSD, PSG, EED, PED, FS, PSL, PSC) which are Substantially complete and Client (or end user) has issued Certificate.

#Substantial completion shall be based on 80% or more works completed under the contract and Commissioned.

- 4.1.2 **Financial Standing:** In addition to the Criteria mentioned in the Tender Documents, the following financial standings will also be considered.
 - i. T1 Liquidity: The Bidder must demonstrate that its financial resources less its financial obligations for its current contract commitments, meet or exceed the total requirement for the Subject Contract of INR10.44Cr.
 - ii. **T2 Net Worth:** As a minimum, the Bidder's net worth should be positive for at least 03 years out of last 05 financial years calculated as the difference between total assets and total liabilities.
 - iii. Average Annual Turnover: Minimum average annual turnover of INR 94.00
 Cr calculated as total certified payments (certified by CA) received for contracts in progress or completed, within the last 05 years.
 - **iv. Bid Capacity Criteria:** The tenderers will be qualified only if their available bid capacity is more than the approximate cost of work as per EQC.

9.0 Tender submissions will be made online after uploading the mandatory scanned documents. Bid shall be submitted online on the GoM Mahatender portal in "two (2) electronic envelopes (e-envelope) system" within prescribed schedule.

A. e-Envelope "A" (Tender Fee, EMD and PoA):

Bidder should generate and upload the following:

- i. Receipt for e-tender fee.
- ii. Receipt of Challan of online payment of Tender Security (EMD),
- iii. Copy of Bank Guarantee towards balance Tender Security (EMD)
- iv. Specific Power of Attorney supported with Board resolution.
- v. Technical bid Bidder shall upload scanned copies of Tender Documents (or digitally signed Tender Documents).

B. e-Envelope "B" (Financial bid):

Bidder shall quote his offer based on his filled Cost Centers / Schedules and upload scanned copies of his financial bid.

Bids will be opened promptly after the deadline for bid submission in the presence of Bidder's representatives who choose to attend.

10.0 Single-Stage Two Envelope:

Bidder should note that there are two envelopes. One for Technical Bid / Package and other for Financial Bid / Package.

The first envelope is Envelope A which consists of Tender Security (EMD and Bank Guarantee), cost of Tender Fee and consist of all Technical Documents.

The Second envelope is Envelope B which consists of Financial Bid / Package. Bidder has to submit their financial bid in Envelope B.

Bidder shall quote his offer based on the Pricing Document of Section 4B.
