2.0 QUALIFICATION CRITERIA

2.1 Minimum Eligibility Criteria:

2.1.1 Work Experience:

A. Contracts of Similar Size and Nature

• General Construction Experience: Experience under the Construction Contracts in the role of prime contractor, JV/Consortium Member or Management Contractor for at least the last 10 years.

• Specific Construction and Contract Management:

i) Tenderer should have Experience of satisfactory completion of similar works as under, as a prime contractor, Joint Venture Firm, Management Contractor or sub-contractor during last 10 years up to last day of month previous to the one in which bids are invited.

a) One contract of **"*similar works" of INR 45.89 Crores** or more

OR

b) Two contracts of **"*similar works" of INR 28.68 Crores** or more

OR

c) Three Contracts of **"*similar works" of INR 22.94 Crores** or more

ii) Experience in Intermodal Ticket integration using Security Key arrangement for contactless fare media, at least for 03 Transport Operators (3 modes of transport offered by one transport operator or 3 different transport Operator/Organization) shall qualify under the clause

* Similar works shall mean design, manufacture, supply, installation, testing, commissioning and maintenance of contactless fare media-based AFC system (comprising of AFC gates, TOMs,TVMs,Station Computers and Central Computer) for Metro/LRT rail projects for which client (or end user) has issued Operational Certificate.

If the bidder is a Foreign bidder or JV/Consortium and has a foreign partner and the above work(s) have been done by the Foreign Bidder / foreign partner of JV and such work(s) were done in the country of the Foreign Bidder / foreign partner then in addition to this, the foreign partner must have done at least one work of value INR 22.94 Crores or more of similar nature outside the country of origin of the Foreign Bidder / foreign partner

- **2.1.2 Financial Standing:** In addition to the Criteria mentioned in the Tender Documents, the following financial standings will also be considered.
 - i. **T1 Liquidity:** The Bidder must demonstrate that its financial resources less its financial obligations for its current contract commitments, meet or exceed the total requirement for the Subject Contract of **INR 4.99 Crores**
 - **ii. T2 Net Worth:** As a minimum, the Bidder's net worth should be positive for at least 03 years out of last 05 financial years calculated as the difference between total assets and total liabilities.
 - iii. Average Annual Turnover: Minimum average annual turnover of INR.
 44.81Cr Crorescalculated as total certified payments (certified by CA) received for contracts in progress or completed, within the last 05 years.
 - **iv. Bid Capacity Criteria:** The tenderers will be qualified only if their available bid capacity is more than the approximate cost of work(57.36 Cr) as per EQC.
