Invitation for Bid

1. Bidding Conditions

The Purchaser of this bidding project (project name: <u>Procurement and Installation for</u> <u>Boarding Bridge of Hohhot New Airport financed by New Development Bank Loan</u>) is Hohhot Airport Construction Management Investment Co. Ltd. The fund for the bidding project is from <u>loans of New Development Bank and financial supporting funds</u> (fund source), the <u>contribution ratio is 80% from New Development Bank loan and 20% from financial matching</u> <u>funds</u>. The project has already met the Bidding Conditions, and now <u>procurement and</u> <u>installation for boarding bridge</u> is subject to public bidding.

2. Project Overview and Bidding Scope

2.1 Project Name: <u>Procurement and Installation for Boarding Bridge of Hohhot New</u> <u>Airport financed by New Development Bank Loan</u>;

2.2 Bidding Scope: <u>The scope of this bidding is the procurement and installation of 25 sets</u> of passenger boarding bridges, including but not limited to the further design, manufacturing, factory inspection, transportation, storage, installation, commissioning and preliminary inspection, trial operation, cooperation of industry acceptance, training and related after-sales services. See details in Chapter V "Requirements for Supply of Goods";

2.3 Delivery Place: <u>Designated place at construction site of Hohhot New Airport,</u> <u>Qiaoshiying Town, Helingeer County, Hohhot City</u>;

2.4 delivery time: <u>It shall be subject to the actual project progress, and the specific time</u> <u>shall be notified 4 months prior to the delivery time.</u>

3. Qualification Requirements for Bidder

3.1 The bidder shall be manufacturer with independent legal person status;

3.2 <u>The bidder shall be from member country of the New Development Bank (including</u> <u>Brazil, Russia, India, China, South Africa, Bangladesh, Egypt and United Arab Emirates (UAE),</u> <u>and the other member countries formal joined the New Development Bank before the</u> <u>deadline for bid submission), and not sanctioned or prohibited from bidding by the</u> <u>government at all levels of the member country of New Development Bank;</u>

3.3 Equipment proposed to be supplied by bidder shall be notified in "Special equipment management system of civil airport" on the website of Civil Aviation Administration of China with status of "normal";

3.4 <u>The bidder's net profit of each year in past 3 years (2020, 2021 and 2022) shall be</u> <u>positive</u>;

3.5 <u>The bidder shall have completed at least one boarding bridge of airport passenger</u> <u>supply experience in the past 5 years (from January 1, 2018 to the deadline for bid submission,</u> <u>the date of experience shall be determined by the date of acceptance certificate</u>);

3.6 Domestic bidder shall not be included into the list of dishonest persons subject to enforcement by the website of "Credit China" (www.creditchina.gov.cn/) or "China Executive Information Disclosure Network" (http://zxgk.court.gov.cn/);

3.7 <u>Different entities with the same person in charge or with holding or management</u> relationship shall not participate in the bidding of this project at the same time;

3.8 Bid by Joint Venture is not accepted for this bidding.

4. Bidding Registration

5.2 The price for each set of Bidding Documents is RMB 1,000 or USD 150 and it is non-refundable.

6. submission of bid

6.1 The deadline for submission of bid (deadline for bid, the same below) is <u>2023-09-27</u> <u>14:00:00</u>, and the place is <u>bid opening room on the third floor of Beijing Construction</u> <u>Engineering Contracting and Trading Center. The specific bid opening room is subject to that</u> <u>displayed on the display screen in the bid opening area (No. 32, Dongwangzhuang Community,</u> <u>Qinghua East Road, Haidian District, Beijing)(</u><u>Submission method of bids: by hand or mailing;</u> <u>submission of bid by email is allowed and only for foreign bidder. If bid is submitted by mail,</u> <u>the bidder shall ensure that its bid is delivered to the address for opening of bids before the</u> <u>deadline for submission of bids, otherwise the Purchaser has the right to reject to the bid. If</u> <u>the bid is lost or damaged during mailing, the risk arising therefrom shall be borne by the</u> <u>bidder.
