3. Open competitive bidding will be conducted in accordance with NDB's single stage two envelope procedure and is open to all bidders from eligible countries as described in bidding document.

4. Only eligible bidders with the following key qualifications defined in the bidding document may participate in this bidding.

5. Minimum Eligibility Criteria:

5.1 Experience and Past Performance: The experienced Bidder should have successfully completed similar works/services during last five years ending 30th April 2025 as follows:

5.1.1 At least one similar completed work/service costing not less than an amount equal to 80% of the estimated cost of the tender Or

5.1.2 At least two similar completed works/services each costing not less than an amount equal to 50% of the estimated cost of the tender Or

- 5.1.3 At least three similar completed works/services each costing not less than an amount equal to 40% of the estimated cost of the tender.

MSME exemption , (subject to meeting quality & technical specifications) as per NDB guidelines.

Note: This project is funded by New Development bank.

- 5.2 Definition of Similar Work: Works involving supply, Installation, Testing, and Commissioning Turnkey Training Facility Development at previous projects that involved the creation and setup of advanced training facilities, covering the supply of audio-visual equipment, installation of softwares and systems, testing for functionality, and final commissioning of the facility. This includes providing necessary materials, installing infrastructure (like electrical and AV systems), ensuring all systems work through testing, and completing the final setup for operational use. The term specifically refers to projects of a similar nature, scale, and technical requirements, such as the development of government academic or specialized training centres.

Bidders shall submit the copies of end user performance along with bid as a supporting document from the client side proving successful supply and installation.

5.3 Financial Standing-

Average Annual financial Turn Over during the last 3 financial years ending 31st March, 2024 should be at least 30% of estimated cost of tender. Audited Balance Sheets of previous three financial years duly certified by C.A.

MSME exemption for financial qualification, (subject to meeting quality & technical specifications) as per NDB guidelines.

Note: This project is funded by New development bank.

Profit & Loss Statement of last three financial years ending 31st March, 2024 duly certified by C.A.

Income tax return of last three financial years ending 31st March, 2024.

The Bidder shall have a 'GST Registration Number' in the name of the Bidder and details of the same should be furnished along with the Tender submittals. GST registration certificate shall be submitted which should be in the name of Bidder.

The Bidder shall submit certified copy of Income Tax PAN Card which should be in the name of bidder.

Solvency Certificate: Bidders should upload scanned copy of Solvency Certificate to the extent of 20% of the estimated cost of the tender from Nationalized Bank or Scheduled Bank at the time of Bid submission.

- 5.5 It contains all the OEM Authorizations product-wise as required by the detailed technical specifications (Appendix 17).

- 5.6 It contains datasheets product-wise as required by the detailed technical specifications.

5.8 Duly filled line by line technical compliance of each product (as part of detailed technical specifications as per Appendix 17) with clear indication of make and model of products being quoted supported by OEM's technical literature. This literature must also be available on OEM's website for verification.

5.9 The Bidders and their respective officers, employees, agents and advisers shall observe the highest standard of ethics
