I. Bidding Conditions

General Contracting for Planting Construction under the Hohhot New Airport Project has been approved by "Reply to the Preliminary Design and Budget of the Airport Engineering (Second Batch) of the Hohhot New Airport Project" Letter No. 2020 [194] issued by Civil Aviation Administration of China in North China and Development and Reform Commission of Inner Mongolia Autonomous Region and achieved bidding condition. Hohhot Airport Construction Management and Investment Co., Ltd (hereinafter called "the Purchaser") conducts open bidding for above-mentioned construction financed by the New Development Bank and counter part finance funds.

II. Project Brief and Scope of Works

- 2.1. Project Name: General Contracting for Planting Construction under the Hohhot New Airport Project Financed by the New Development Bank.
- 2.2. Construction Site: Hohhot New Airport Project, Qiaoershiying Town, Horin Ger County, Hohhot, Inner Mongolia Autonomous Region, P.R.China.
- 2.3. Project Brief: New planting construction for Hohhot New Airport, located near Daxinying Village, Qiaoershiying Towns, Horin Ger County, Hohhot City, Inner Mongolia Autonomous Region, with a land area of approximately 73.12 hectares. The main content of construction includes the terminal area planting (road planting, roadside planting, traffic center roadside planting, planting under viaduct, parking lot planting which are visible during ground inbound and outbound of the airport), the main entrance road planting, and road planting of the east-west working area.
- 2.4. Scope of Works: Including earthwork construction, planting construction, civil construction, lighting construction, landscape construction and other construction, supporting construction (irrigation and electrical construction), etc

of the terminal area planting (road planting, roadside planting, traffic center roadside planting, planting under viaduct, parking lot planting which are visible during ground inbound and outbound of the airport, with planting area of 45.85 hectares), the main entrance road planting (with planting area of 11.6 hectares), and road planting of the east-west working area (with planting area of 15.6 hectares). Details included in the drawings and bill of quantities shall prevail.

- 2.5. Construction Period: 730 calender days, planned commence date: October 30, 2023, planned completion date: October 30, 2025.
- 2.6. Number of lots: 1.

III. Qualification Requirements of the Bidder

- 3.1. The bidder shall be a legal entity or organization participating in bidding competition and have the qualification to independently sign contract;
- 3.2. The bidder shall come from member countries of the New Development Bank and not be restricted from bidding by the governments of the member countries of the New Development Bank;
- 3.3. The bidder shall have at least one experience of similar landscape planting construction with an individual contract amount of no less than CNY 100 million (or equivalent foreign currency) in recent 3 years (from Jan 1, 2020 to deadline for bid submission);
- 3.4. The bidder's net profits of each year shall all be positive in recent 3 years (2020, 2021 and 2022);
- 3.5. The bidder from within P.R. China shall not be included in the list of persons subject to enforcement for dishonesty published by the website of "Credit China" (www.creditchina.gov.cn) or China Executive Information Disclosure (zxgk.court.gov.cn);
- 3.6. Joint Venture is not allowed.
