

# INVITATION FOR BID

For Contract No. W-06 & W-07 Under Reconstruction Engineering of Road G329 (Gaotang to Mabu)  
[Bid No.: 2024AFWGZ02726]

## 1.Bidding Conditions

The Reconstruction Engineering of Road G329 (Gaotang to Mabu) has been approved by the Chuzhou Municipal Development and Reform Commission, and the construction drawing design has been approved by the Chuzhou Municipal Transportation Bureau — "Chujiao Planning [2022] No. 1" document. The tenderer is the Dingyuan County Transportation Bureau. The project has met the bidding conditions, and the construction of the project is now open for bidding.

## 2.Project Overview and Bidding Scope

The route of the G329 Gaotang to Mabu Bridge Section Reconstruction Project starts from Gaotang Village, passes through Zhangqiao Town, and ends at Mabu Bridge in Lianjiang Town. The total length of the route is 21.948 km.

The construction site of this project is located in Dingyuan country, Chuzhou City, Anhui Province. The purchase scope covers all the items listed in the construction drawings and the bill of quantities. The description or work, estimated construction period, the Engineering's Estimated Value and contents of each Contract are as follows :

The total length of the road is 11.948 km (K10+000-K21+948), the width of the subgrade is 32 m, the width of the pavement is 28.5 m, the speed is 80 km/h, and the asphalt concrete pavement. The main construction contents include roadbed, pavement, bridge and culvert, traffic facilities, intelligent traffic management, greening and supporting projects.	730	452,620,997.49

## 3.Qualification Requirements

3.1 The qualifications and experiences of the Bidder shall meet the requirements of personnel, equipment, financial status & etc. that suitable for Contract performance. Foreign Bidder shall provide relevant certification issued by his government that equivalent to China's domestic certificates. detail as follows:

1. Qualification Grade

All Bidders under each contract shall have independent legal personality, and holding 1) Certification of "Highway engineering construction general contracting" Grade I or above issued by the Ministry of Housing and Urban-Rural Development, and 2) Work safety License (within validity period).

2. Experience:

Within last 5 years (from January 1<sup>st</sup>, 2019 to date of bid submission, subject to the issuing date of Final Acceptance) shall have completed at least: One contract of new-built or rebuilt highway Grade I with a length of no less than 10km. The construction of under the Contract should include roadbed or pavement works, and the total Contract Value should not less than CNY200,000,000.

3. Project Manager:

- 1) The project manager proposed shall have Certificate of "National certified Constructor Professional level One of Road Engineering" and "Examination Certificate B of Work Safety" issued by provincial or above transportation department.
- 2) Within last 5 years (from January 1<sup>st</sup>, 2019 to date of bid submission, subject to the issuing date of Final Acceptance) shall have conducted as project manager at least: One contract of new-built or rebuilt highway Grade I with a length of no less than 10km; The total Contract Value should not less than CNY200,000,000. The construction of each of above mentioned Contract should include roadbed and pavement works.
- 3) The proposed project manager shall not serve as the project manager of other projects on date of bid submission.

The proof documents for each of the Contract submitted under the request of experience as mentioned in above Clause 2, and 3 shall include: 1) scanned copies of <Letter of Contract Award>, <Contract Documentation>, <Final Acceptance>; and 2) Screenshots of "Experience Information" downloaded from National Highway Construction Market Credit Information Management System (<http://glxy.mot.gov.cn>). Web screenshots shall specify the online search path for obtaining the screenshots. If all of the above-mentioned documents cannot prove the conformity of experience in detail, the bidder shall also provide documents describing the characteristics of the works, including the Bill of Quantities under the contract. The completion date of each Contract shall be subjected to the issuing date of Final Acceptance.

4. Financial Requirements:

1) The average annual turnover of bidders in the recent three years (year2021, 2022 and 2023) is not less than 1.5 billion yuan; 2) The bidder shall issue a bank reference through a state-owned or joint-stock commercial bank at the sub-branch level or above, stating that the special credit line obtained by the bidder for the implementation of the project shall not be less than 80 million yuan.

5. Eligibility —None of the following bidders will be accepted.

- 1) Disqualified from bidding in Anhui Province or prohibited from entering the highway construction market in Anhui Province by the transportation authorities at the provincial level or above, and within the penalty period.
- 2) In a state of being ordered to suspend business, financial receivership, freezing,

bankruptcy.

- 3) The bidder and/or its legal representative, the recommended project manager, and the technical director have committed the crime of bribery.
  - 4) The bidder in the "China Executive Information Disclosure Network" (<http://zxgk.court.gov.cn/shixin/>) was faithless person subjected to execution list.
  - 5) Blacklisted by international financial organizations and within the penalty period.
  - 6) Debarred by any government agencies from NDB member countries. Please indicate it in the "Commitment Letter of Bad Records" in Appendix I, Section 9.
  - 7) It is prompted as a "risk trading object" by the "Hefei Public Resources Trading Center Electronic Service System".
  - 8) There are other circumstances that restrict their bidding as stipulated by Chinese laws and regulations.
6. Other requirements: The bidder shall have corresponding abilities in general personnel and equipment. Please refer to the bidding documents for specific requirements.
7. Bidders are requested to log in the list of qualified enterprises for highway construction in the National Highway Construction Market Credit Information Management System (<http://glxy.mot.gov.cn>) and confirm that the information in the list is completely accurate.

3.2 Joint Venture, Consortium or Association were not acceptable.

3.3 The bidder could select one or total 2 contracts to bid for. However, each bidder could be awarded only under one contract.

3.4 Bidders must strictly avoid conflicts with other assignments or their own interests, and act without consideration for future work. Bidders found to have a conflict of interest shall be disqualified. Different units with the same person in charge or holding or managing relationship shall not participate in the same bidding section; otherwise, the bids shall be deemed invalid.

3.5 The bidder in the "China Executive Information Disclosure Network" (<http://zxgk.court.gov.cn/shixin/>) was faithless person subjected to execution list, is not accepted.
