The selection of firms would involve three stage bid system (Pre-qualification, 3. Technical and Financial). In the first pre-qualifying stage, the BRRDA will select the firms based on the past credentials (Experience of similar project, financial capacity). Those who qualify in the first stage will be evaluated for technical proposal and financial proposal on QCBS basis with 80:20 weightage for technical and financial scores respectively.

The proposal shall be submitted in English language and all correspondences would 4.

be in same language.

As per the Terms and Conditions of the RFP, the consultant shall perform all the 5. duties as per the Condition of TOR given in RFP along with any amendment thereof. The selection of consultant shall follow the laid down procedures given in the RFP document.

- Bid processing cost Rs. 10,000/- (Non-Refundable) have to be deposited by each 6. consultancy firm in the form of bank demand draft issued from Nationalized/ Scheduled Indian bank in favour of Secretary, BRRDA, RWD, Bihar payable at
  - Patna.

- The Consultant shall be required to submit acceptable Bank Guarantee (BG)/ Fixed 7. Deposit Receipt (FDR) issued from Nationalized Bank/Scheduled Indian Bank for an amount equal to Rs. 5,00,000.00 (Five Lakhs) towards Bid security. The Fixed Deposit Receipt (FDR) shall be valid for six months after last date of receipt of tender and shall be duly pledged in favour of Secretary, BRRDA, RWD, Bihar payable at Patna. The Bank Guarantee (BG) shall be valid for 45 days beyond the validity of the bid and shall be issued from any Nationalized Bank/Scheduled Indian Bank issued within the state in the format given in Annexure-1 of EOI cum RFP document (If issued from any bank outside state shall be converted to any bank within the state before executing the agreement).
- Original Demand Draft of Cost of Bid Document in the form of DD, Bid Security in 8. the form of Bank Guarantee (BG)/ Fixed Deposit Receipt (FDR) and duly notarized Power of Attorney shall be placed in an envelope and must be submitted at the office of Engineer-in-Chief, Rural Works Department, 5th Floor, Vishweshwaraiya Bhawan, Patna-800015 either by registered post or by hand on and before date and time specified above in Schedule of dates, failing which the proposal will be rejected. Applicants WILL NOT WRITE THEIR NAMES OR THEIR FIRM'S NAME on this envelope. Any bidder who discloses their name or firm's name on the envelope will be disqualified.
- When the applicant submits his bid on-line, he will get an acknowledgement of 9. submitted bid. The number mentioned on this acknowledgement only will be mentioned on the envelope containing original affidavit, DD for Bid processing cost and Bid Security. This is essential to maintain the confidentiality of bidder.

A copy of acknowledgement slip will be put inside this envelope to ensure proper identification of the bidder.

All the submitted documents shall have the signature of the consultancy firm or their 10. authorized signatories.

BRRDA reserves the right to extend/cancel the tender (RFP) at any stage without 11. assigning any reason thereof.
