

Invitation for Bid

1. Bidding Conditions

Construction of the Departure System for the Weak Current System Project(Lot 5) of the New Hohhot Airport financed by New Development Bank Loan (Project Name), has been approved by CAAC North China Regional Administration and the Development and Reform Commission of Inner Mongolia Autonomous Region (Name of the project approval, verification, or record-keeping authority) under the approval documents: CAAC North China Regional Administration Letter [2019] No. 272, CAAC North China Regional Administration Letter [2020] No. 194, and Inner Mongolia Development and Reform Commission Letter [2023] No. 249 (Names and numbers of the approval documents). The project owner is Hohhot Airport Construction Management Investment Co. Ltd., the fund for this bidding project is from loans of New Development Bank and financial matching funds (fund source), the contribution ratio is 70% from New Development Bank loan and 30% from financial counterpart funds, the Purchaser is Hohhot Airport Construction Management Investment Co. Ltd. The project has met the conditions for bidding and is now open for public bidding.

2. Project Overview and Bidding Scope

2.1 Project Name: Construction of the Departure System for the Weak Current System Project(Lot 5) of the New Hohhot Airport financed by New Development Bank Loan;

2.2 Construction Location: Qiaoshiying Town, Helinge'er County, Hohhot City;

2.3 Project Overview: The design of the weak current system for Hohhot New Airport makes full use of electronics, communication, networking, and information processing technologies to unify the organization, coordination, scheduling, and management of various aspects, links, and positions involved in civil aviation airport transportation production and administrative management, achieving comprehensive informatization management. Within the airport, various weak current information systems are able to share information and operate collaboratively, providing all-around information services to passengers and the public, as well as accurate and timely decision-making support, management support, and information services to airport management, dispatchers, and service personnel, maximizing the airport's economic and social benefits;

2.4 Planned construction period: From the date of contract signing, the completion and acceptance of the project is scheduled to be before December 31, 2024, with actual progress subject to the implementation schedule of the project and the requirements of the Purchaser;

2.5 Bidding Scope: Construction of the Departure System for the Weak Current System Project(Lot 5) includes:

1.The departure system, full-process luggage tracking system, self-service equipment (self-check-in devices, self-check-in bag drop devices, self-verification gates at boarding gates, security check verification gates), security information management system, passenger transfer system, and

construction of security check equipment throughout the airport within the scope of the Hohhot New Airport project;

2.The departure system and self-service equipment (self-check-in bag drop devices, self-verification gates at boarding gates) within the scope of the terminal and concourse construction project of Hohhot New Airport.

For specific details on the Bidding Scope, please refer to the technical standards and requirements, Bidding drawings, and Bill of Quantities outlined in the Bidding documents.

2.6 Bidding Lot Division: One .

3. Qualification Requirements for the Bidders

3.1 The Bidders must have independent legal status and must be from member countries of the New Development Bank (including Brazil, Russia, India, China, South Africa, Bangladesh, Egypt, and the United Arab Emirates, as well as any other official member countries that joined the New Development Bank before the bid submission deadline). Additionally, the Bidders must not be sanctioned or prohibited from bidding by governments at any level of member countries of the New Development Bank;

3.2 The Bidders must hold a First-Class qualification in the field of civil aviation control engineering and airport weak current system engineering issued by the housing and urban-rural development authority, as well as a safety production license;

3.3 The Bidders' proposed project manager must hold a First-Class Registered Constructor qualification in the field of civil aviation airport engineering or electromechanical engineering, and must not be engaged in any ongoing construction projects. If the project manager is involved in other ongoing construction projects, they must comply with the requirements set forth in the "Notice from the Airport Department of the Civil Aviation Administration regarding further clarification of the qualifications of registered constructors serving as project leaders for construction projects";

3.4 The Bidders must have at least one completed project in the field of civil aviation airport weak current system engineering (departure system must be included) within the past 5 years (from January 1, 2019, to the bid submission deadline);

3.5 The Bidders' net profit of each year in past 3 years (2021, 2022 and 2023) shall be positive;

3.6 Domestic Bidders shall not be included into the list of dishonest persons subject to enforcement by the website of "Credit China" (www.creditchina.gov.cn/) or "China Executive Information Disclosure Network" (<http://zxgk.court.gov.cn/>);

3.7 Different entities with the same person in charge or with holding or management relationship shall not participate in the bidding of this project at the same time;

3.8 Joint Venture is not accepted.

4. Bidding Registration

4.1 The Bidders shall make bid registration in Civil Aviation Engineering Construction Project Tendering and Bidding Management System (<http://zbtb.caac.gov.cn/>) with registration data or send the registration materials via fax to /or send the electronic version of the scanned copy of the registration data to liwenduo@minmetals.com for bid registration during the period from 2024-07-25 09:00:00 to 2024-08-05 17:00:00 (except public holidays and legal holidays).

The registration data includes ① business license or registration certificate; ② identity certificate of the legal representative or power of attorney; ③ ID card and contact information (including name, telephone number, email, address, etc.) of the agent. All above documents shall be affixed with official seal.

Note: The Bidders shall complete registration online in Civil Aviation Engineering Construction Project Tendering and Bidding Management System (<http://zbtb.caac.gov.cn/>).

5. Acquisition of Bidding Documents

Alternatively, the Bidders may download the Bidding Documents from the Civil Aviation Professional Engineering Construction Project Bidding Management System during the same period and must purchase the paper version of the Bidding Documents before the deadline for bid submission. The paper version of the Bidding Documents shall prevail.

5.2 The price for each set of the Bidding Documents is CNY 1,000 Yuan, technical materials and other documentation are available for free. Please note that all sales are non-refundable .

5.3 For those purchasing Bidding Documents by mail, an additional handling fee (including postage) of CNY 150.00 Yuan is required. the Purchaser will send the documents within 2 days after receiving the handling fee (including postage).

6. submission of bid

6.1 The deadline for submission of bid (deadline for bid, the same below) is 2024-08-27 14:30:00, and the place is bid opening room on the third floor of Beijing Construction Engineering Contracting and Trading Center. The specific bid opening room will be determined based on the display screen in the bid opening area, located at (No. 32, Dongwangzhuang Community, Tsinghua East Road, Haidian District, Beijing).

6.2 late bid, delivery of wrong address or not sealed as required in the Bidding Documents will be rejected by the Purchaser.
