

# **Bidding Announcement**

## **Lanzhou Zhongchuan International Airport Phase III Expansion Project Special Vehicle Procurement Project Second Batch (Seven Section) Bidding Announcement**

### **1. Bidding conditions**

This bidding project, Airport Works of Lanzhou Zhongchuan International Airport Phase III Expansion Project, has been approved for construction by CAAC Northwest Regional Administration and Gansu Provincial Development and Reform Commission according to the Reply of CAAC Northwest Regional Administration and Gansu Provincial Development and Reform Commission to Preliminary Design and Budget Estimate of the Airport Works of Lanzhou Zhongchuan International Airport Phase III Expansion Project (MHXBJH [2020] No. 141) and (MHXBJH [2023] No. 132). Gansu Civil Aviation Airport Group Co., Ltd. (GCAG) serves as the Bid Inviter. The funds of the Project come from the budget of the central government, the Civil Aviation Development Fund, the funds allocated by the local government, the self-raised funds and the loans from New Development Bank (NDB). As the bidding conditions have been met, open bidding is now conducted for the Project.

### **2. Project overview and bidding scope**

2.1 Project name: Lanzhou Zhongchuan International Airport Phase III Expansion Project Airport Works Special Vehicle Procurement Project Second Batch (Seven Section) Heavy Water Tanker, Fire Lighting Vehicle, Communication Command Vehicle, Heavy Foam Car, Demolition and Rescue Vehicle, Support Vehicle

2.3 Bidding scope:

The procurement of Heavy Water Tanker(2 sets), Fire Lighting Vehicle (2 sets), Communication Command Vehicle (2 sets), Heavy Foam Car (2 sets), Demolition and Rescue Vehicle (2 sets), Support Vehicle (2 sets) for the Airport Works of Lanzhou Zhongchuan International Airport Phase III Expansion Project includes but is not limited to the supply, transportation, loading and unloading, debugging, trial operation of firefighting vehicles purchased this time, cooperation with various stages of acceptance, provision of technical training and after-sales service, and other work.

Refer to Chapter V, "Requirements of Supply", for details of specific equipment.

2.4 Place of delivery: Lanzhou New Area (Landed delivery);

2.5 Date of delivery: Within 3 months of signing the contract, all vehicle supply conditions shall be met (the specific time shall be subject to the notice issued by the tenderer)

### **3. Qualification requirements of the Bidder**

3.1 The Bidder must be a corporate body or company formally registered within the border of any member state of NDB (including the People's Republic of China, the Republic of India, the Federative Republic of Brazil, Russia, the Republic of South Africa, Uruguay, the United Arab Emirates, Bangladesh and Egypt) with a valid independent legal person qualification; and the proposed equipment must be manufactured by the member states of NDB.

3.2 The Bidder must be a manufacturer able to complete the bidding equipment( must provide the Declaration of Manufacturer).

3.3 The same person serving as the head of different units, or different units with holding or administrative relationship cannot bid this bidding project at the same time.

3.4 The Bidder must provide the audited financial reports in recent three years (from 2020 to 2022). If its existence is less than three years, the audited financial reports since establishment must be provided. If its existence is less than one year, the credit certification issued by the bank must be provided.

3.5 The Bidder must submit the tax certificates in any consecutive three months in the recent year. If its existence is less than three months, the tax certificates since establishment must be provided.

3.6 The companies and individuals (legal representative of the Bidder and the leader of the proposed project) included by the people's court in the list of trust-breaking persons subject to enforcement are not accepted for this bidding. The Bidder must provide the screenshots of the following search results: (1) the search information of the companies, legal representatives and the leaders of the proposed project after the deadline for bidding registration on the website of "Credit China" ([www.creditchina.gov.cn](http://www.creditchina.gov.cn)) and its related websites jumped. The Bidder shall inquire the information on the website of "Credit China" first, and must provide the jumping screenshots (if any) and the screenshots of relevant search results; and (2) the screenshots of search results about the enterprises not included in the list of seriously illegal and dishonest enterprises (information of the Bidder) after the deadline for bid registration in the "National Enterprise Credit Information Publicity System" ([www.gsxt.gov.cn](http://www.gsxt.gov.cn)).

3.7 The companies restricted by the administration for industry and commerce of the People's Republic of China and the competent authorities of relevant industries for bidding are not accepted in this bid. The Bidder must provide the Letter of Commitment for Unrestricted Bidding or Transactions prepared in the format as agreed in the Bidding Documents in Bid Documents.

For any false commitment, the consequences shall be borne by the Bidder. The bid evaluation (review) committee shall cancel the bid qualification of the companies included in the list of trust-breaking persons subject to enforcement or restricted for bidding, or directly reject the bid.

3.8 The Bidder which has been declared ineligible by any member state of NDB in the recent 5 years (from July 2019 to July 2024) is forbidden in the bid.

3.9 The consortium is not accepted in this bidding.

**Post-qualification is applied in this bidding. The Bidder shall make its own judgment for consistency with the Notice, and decide upon the participation in the bidding.**

## **4. Acquisition of the Bidding Documents**

4.1 Acquisition date: from **18:00 on July 10 2024 to 18:00 on July 15 2024** (Beijing time). All the intentional bidders should download the Bidding Documents on the website of Gansu Provincial Public Resources Trading Center for free

4.2 Acquisition website: Gansu Provincial Public Resources Trading Network (<http://ggzyjy.gansu.gov.cn/>)

4.3 Acquisition method: download from Gansu Provincial Public Resources Trading Network. All the potential applicants who intend to participate in the public resources trading activities in Gansu Province must first register on the Gansu Provincial Public Resources Trading Network, and are allowed to free download or check the Bidding Documents and carry out other follow-up work (refer to the Bidding Documents (or pre-qualification) documents for details) after successful registration by "username + password + verification code" to log in or by CA digital authentication to log in.

(2) Requirements for the starting and ending time of "I Want to Bid" stipulated in the Bidding Documents are as follows: The deadline for online "I Want to Bid" is the deadline specified in the Bidding Documents (or pre-qualification documents) (the specified time is  $n \times 24h$ ,  $n \geq 5$ ). Applicants shall take the initiative to log in (Gansu Provincial Public Resources Trading Network) before the deadline to submit the application documents for pre-qualification, so as to know the bidding-related information and supplementary information in time. Applicants shall bear the adverse factors by themselves if taking the initiative to log in the website but failing to acquire relevant information.

## **5. Submission of Bid Documents**

5.1 Submission way of Bid Documents: The Bidder shall upload Electronic Bid Documents in the electronic version (one copy in .NGEF, .SNGEF and .CZR respectively. The preparation tools of Bid Documents shall be consistent with those of the Bidding Documents, and the upload channel will be available 24h before the deadline to submit Bid Documents) through Electronic Bid Opening and Evaluation System (<https://ez.lzggzyjy.cn/bid-ejiaoyi-lzs/bidder-login>).

5.2 Deadline to submit Bid Documents: before **10:00 on August 1 2024** (Beijing time). The

Bidding Documents must be uploaded before such time.

5.3 Online bid opening time: **10:00 on August 1 2024.**

5.4 Online bid opening location: No. 1 Bid Opening Hall on 1F of the Gansu Provincial Public Resources Trading Bureau Lanzhou New Area Branch, and Gansu Provincial .

5.5 Late delivery of bidding documents will be rejected by the electronic bidding and trading platform.

5.6 Bidders are required to go to the [www.ejaoyi.vip](http://www.ejaoyi.vip) download center to download and install the "Comprehensive Electronic Bid Document Production Tool" from the Trading Platform. The prepared PDF bid documents will be imported into the tool for solidification and encryption, and generated One NGEF format One copy in SNGEF format A bid document in CZR format. If there are any technical issues, please contact Gansu Trading Information Technology Co., Ltd. in a timely manner to resolve them.
