

# Invitation for Bid

Procurement of Special Vehicles (Lot 1) for Hohhot New Airport financed by New Development Bank Loan

## 1. Bidding Conditions

The Purchaser of this bidding project (project name: Procurement of Special Vehicles (Lot 1) for Hohhot New Airport financed by New Development Bank Loan) is Hohhot Airport Construction Management Investment Co. Ltd. The fund for the bidding project is from loans of New Development Bank and financial supporting funds (fund source), the funds are 80% from New Development Bank loan and 20% from financial counterpart funds. The project has met the Bidding Conditions, and now Procurement for Special Vehicles is subject to public bidding.

## 2. Project Overview and Bidding Scope

2.1 Project Name: Procurement of Special Vehicles (Lot 1) for Hohhot New Airport financed by New Development Bank Loan;

2.2 Bid Scope: The procurement includes 2 gas supply vehicles, 2 air conditioning vehicles, 3 ice-melters, 1 wheelchair boarding vehicle, 13 passenger stair vehicles, 18 baggage conveyor vehicles, 5 lifting platform vehicles, 6 electric towing tractors, 1 electric AC/DC power supply vehicle, 2 electric water vehicles, 2 electric sewage vehicles, and 2 friction coefficient testing vehicles and etc. For more details, please refer to Chapter 5: Supply Requirements.

2.3 Delivery Place: Designated place at construction site of Hohhot New Airport, Qiaoshiying Town, Helingeer County, Hohhot City;

2.4 Delivery period: The delivery, commissioning, and acceptance of the goods must be completed within 3 months after the contract signature and upon receiving written notification from the purchaser.

## 3. Qualification Requirements for Bidder

3.1 Bidders must be manufacturers of the civil aviation specialized equipment (gas supply vehicles, air conditioning vehicles, ice-melters, wheelchair boarding vehicles, passenger stair vehicles, baggage conveyor vehicles, lifting platform vehicles, towing tractors, electric AC/DC power supply vehicles, electric water vehicles, electric sewage vehicles, and friction coefficient testing vehicles) or authorized agents (If the bidder does not possess the manufacturing capability for all or part of the mentioned civil aviation specialized equipment, that portion of the equipment will be considered as being bid by an agent, and the bidder must provide a letter of authorization from the manufacturer of that portion of the equipment for this project. This project only accepts one agent appointed by the manufacturer to participate in the bidding for the same brand and model

of equipment. If a manufacturer appoints more than one agent to participate in the bidding for the same brand and model of equipment, the bids from all involved agents will be deemed invalid;

3.2 Bidders must come from member countries of the New Development Bank (including Brazil, Russia, India, China, South Africa, Bangladesh, Egypt, and the United Arab Emirates, as well as other formally admitted member countries before the bidding deadline), and must not be sanctioned or prohibited from bidding by any level of government in New Development Bank member countries;

3.3 The equipment that the bidder intends to bid for (gas supply vehicles, air conditioning vehicles, ice-melters, wheelchair boarding vehicles, passenger stair vehicles, baggage conveyor vehicles, lifting platform vehicles, towing tractors, electric AC/DC power supply vehicles, electric clean water vehicles, electric sewage vehicles, and friction coefficient testing vehicles) must be listed on the Civil Aviation Administration of China website's "Special Equipment Management System for Civil Airports" and have a status of "Normal";

3.4 The bidder must provide at least one supply contract for special vehicles at a civil aviation airport within the last five years (from January 1, 2020, to the present, based on the contract signing date), and the contract supply content must include at least one type of special vehicle within the scope of this project's bidding;

3.5 The bidder's net profit of each year in past 3 years (2021, 2022 and 2023) shall be positive;

3.6 Domestic bidder shall not be included into the list of dishonest persons subject to enforcement by the website of "Credit China" ([www.creditchina.gov.cn/](http://www.creditchina.gov.cn/)) or "China Executive Information Disclosure Network" (<http://zxgk.court.gov.cn/>);

3.7 Different entities with the same person in charge or with holding or management relationship shall not participate in the bidding of this project at the same time;

3.8 Bid by Joint Venture is not accepted for this bidding.

## **4. Bid registration**

4.1 Bidders are requested to register for bidding from 17:00 p.m Jan 17, 2025 to 17:00 p.m Jan 27, 2025 (excluding legal holidays and statutory holidays). Bidders should bring the registration materials to the Civil Aviation Engineering Construction Project Tendering And Bidding Management System (<http://zbtb.caac.gov.cn/>) for registration, or fax the registration materials to /, or send electronic scanned copies of the registration materials to [liwenduo@minmetals.com](mailto:liwenduo@minmetals.com) for registration.

The registration materials include:

- ① Business license or registration certificate;
- ② Identification proof of the legal representative or power of attorney;
- ③ ID and contact information of the person handling the bid (including name, phone number, email, address, etc.). All documents must be stamped with the official seal.

## **5. Acquisition of Bidding Documents**

5.1(A) Acquisition time of Bidding documents is from 17:00 p.m Jan 17, 2025 to 17:00 p.m Jan 27, 2025 (excluding legal holidays and statutory holidays)

For bidders who require the bidding documents to be mailed, an additional handling fee (including postage) of 150.00 yuan is required. The purchaser will send the documents within 2 days after receiving the company introduction letter, the payment for mail order, and the technical materials deposit (including the handling fee).

5.1(B) Any bidder who is interested to participate in the bidding, please log in to the Civil Aviation Engineering Construction Project Tendering And Bidding Management System from 9:00 a.m Jan 17, 2025 (Beijing time, the same below) to 17:00 p.m Jan 27, 2025 and download electronic bidding documents.

5.2 The price for each set of bidding documents is 2000 yuan, and is non-refundable after sale.

## **6. Submission of bids**

6.1 The deadline for submission of bids (bidding deadline, the same below) is 14:00 p.m. Feb 18, 2025. The place of bid opening is Guang'anmen office zone of Beijing Public Resources Trading Center (No. Jia 68, South Guang'anmen Street, Xicheng District, Beijing) (Bidders should submit the documents either in person or by mail; only foreign bidders are allowed to submit bids via email. In case of mail, bidders must ensure their Bids arrive at the place of bid opening before the deadline for submission; otherwise, the Purchaser has the right to reject the Bids). If the Bids are lost or damaged during the mailing process, the risks arising therefrom shall be borne by the bidder. Mailing Contact: Li Wenduo Phone: +86-10-81125781.

Foreign bidders submitting bids via email must encrypt their electronic bidding documents and send it to liwenduo@minmetals.com before the deadline for submission of bids. The decryption password must be sent to the same email within 15 minutes after the deadline for submission. If bidders fail to submit their Bids and decryption password as required, their Bids will be deemed as rejection.

6.2 (A) In case of late Bids, wrong delivery Bids or Bids not sealed, the Purchaser has the right to reject.

6.2 (B) In case of late e-Bids, the bids will be rejected by the Electronic Tendering and Bidding Trading Platform.
