The People's Republic of China has applied for financing in the amount of RMB 1990 million equivalent from the New Development Bank (NDB) toward the cost of Hubei Huangshi New Port Modern Logistics Hub Project (the Project) and it intends to apply the proceeds to part of the payments for civil works, goods, supply & installations and consulting services and other related activities to be procured under this Project. The Project aims to address the critical physical and digital infrastructure gaps at the Port by promoting the use of railway and conveyor belts for freight movement, enhancing connectivity with nearby industrial enterprises, and improving operational efficiency.

The Project includes the following key components and all the related construction and delivery will be within Huangshi:
