- 1- The Bidder/Contractor/Firm who enlisted or Registered in appropriate class or category by State/Central Government departments or may be a natural person, private Entity, government-owned Entity having organizational structure like firm/Company having all required resources to carry out of work of similar type (as per section III of RFP bid document) are eligible to participate in the bid.

3- Bidders are compulsorily required to deposit sums required against bid security for the amount as specified above, tender document fees ₹ 5000/- (For works Sr. No. 1), ₹ 1000/- (For works Sr. No. 2) and RISL bid processing fees ₹ 2000/- (For works Sr. No. 1), ₹ 1500/- (For works Sr. No. 2.) For work separately or in consolidation (Bid security/Tender Document Fees/RISL bid processing fees or whatever may be the combination) on e-GRAS, online government of Rajasthan revenue receipt system at web portal <https://E-Gras.raj.nic.in/> following procedure as suggested below:

(i) Bidders are required to register as registered user on E-Gras web portal.

(ii) Create profile with Department (214 water resources department (CE, Hanumangarh) for separate challan payments for bid security, tender Document Fees and RISL bid processing fees) paid separately.

(iii) The consolidate payment for (Bid security amount/Tender Document Fees/RISL bid processing fees) can be made directly through service challan option at portal.

(iv) Bidders are required to deposit required sums against bid security, tender document fees and RISL fees in following budget heads and respective division code as detailed in point no. 04 at E-GRAS portal through online payment gateway system: -

(v) After successful payment of all above fees in a single or individual challan as the case may be, Bidder will generate CIN No. receipts.

(vi) Bidders are required to upload scanned copy of CIN receipts along with his technical bid proposal at procurement portal www.eproc.rajasthan.gov.in

4- Bid security, Tender cost and RISL bid processing fees in a single or separate e-challan shall be in favor of as below:-

5- Bid security can also be submitted through a banker's cheque or demand draft as per Rule 42(6) and Rule 45(2) of RTTP Rule. If submitted through Bank Guarantee, it should be from Scheduled Bank of India and shall be submitted with a validity of 30 days beyond the original or extended validity period of the bid as per Rule 42(6) of RTTP Rules. Original copy of banker's cheque/demand draft/Bank Guarantee shall be submitted in this office up to date 11.03.2026 TIME 11:00 AM.

6- The bid not uploaded in prescribed form will be rejected without mentioning any reason.

7- All pages and schedules of original bid supporting documents should be essentially filled in and should be signed on each page by the bidder or his authorized representative.

8- Online Bid will be received and opened on dates mentioned above by the procurement committee or by an officer authorized in presence of intending bidders or their authorized representatives. No physical/off-line Bid shall be accepted in any case.

9- The bid shall be valid for 90 days from the date fixed for bid submission deadline.

10- The Department reserves right to reject any or all Bids or to accept them in part, without assigning any reason thereof.

11- In case there is a Gazetted holiday declared on the date of opening of the Bid the same will be opened on next working day at same time.

12- The Department shall not be liable for any delay in uploading the Bid document on website, Bidders are advised to upload bid and all documents on or before scheduled date and time.

13- Before submitting the bid, the bidder should ensure that all the related documents have been scanned, duly signed by the bidder or his authorized representative and attached with the bid.

14- Conditional Bids uploaded by the bidder shall not be accepted.

15- The pre bid meeting will be held on 24.02.2026 Time 11:00 AM in this office.

16- Appropriate action as per RTTP Act/Rules shall be taken against the bidders who will not upload bid scanned copies of required e-Challan with CIN receipts for the Bid security, tender cost and RISL bid processing fees with his bid proposal on eproc portal.
